
PETITION TO REINSTATE AND HOLD IN ABEYANCE

WH Bass, Incorporated and American Interstate Insurance Company (“Appellants”) petition this Court to reinstate the appeal. Appellants also seek to have the appeal held in abeyance pending settlement approval by a Florida state probate court and the South Carolina Workers’ Compensation Commission. As grounds for this petition, Appellants raise the following issues:

1. Appellants filed the notice of appeal on January 8, 2013.
2. Since filing the notice of appeal, the parties have settled all issues on appeal.
3. Respondent is currently seeking approval of the settlement from a Florida state probate court.
4. Upon approval of the settlement agreement from the Florida state probate court, the parties shall seek approval from the South Carolina Workers’ Compensation Commission.
5. At such time, as the Florida state probate court and the South Carolina Workers’ Compensation Commission approve the settlement, the documents shall be filed with the South Carolina Court of Appeals.
