Facts of The Case

1. In Appellant's August 23rd, 2017 Parole Hearing, then ~~Board Member~~ Ms. Kim Frederick made an implicit agreement to grant Appellant parole at his next hearing if he continued to keep his four year disciplinary record clean. However, Ms. Frederick did not keep the legally binding verbal contract (which was made on record) when she denied him parole at his following hearing on Nov. 13th, 2019 despite Appellant's continued good behavior. The last institutional infraction the Appellant had was in 2013 (which was a non-violent cell phone charge). And since then, not only has Appellant remained disciplinary free but has also completed numerous character development classes in preparation for his success upon release. Had Ms. Frederick (who was and now is the Chair Person at the time of the Appellant's 2019 hearing) satisfied the terms of the verbal contract she made at his 2017 parole hearing, her tie-breaking vote would have guaranteed his parole release.

Supporting Facts

2. Due to a computer glitch on Nov. 13, 2019 the Appellant was not given the adequate time needed to respond to the Parole Board's second question concerning his remorse for the victims family in his case. Had Appellant been given the proper time necessary to respond to this most crucial question, the outcome of his parole hearing would have more likely resulted in the granting of his release.

DISCUSSIONS

Out of all due respect, I'm asking this court for a fair review in this matter (or dismissal). Therefore, based on the above, the Board's decision should be reversed and the matter remanded back to the Board with instructions to provide Appellant with a "full and fair" parole hearing in this matter.

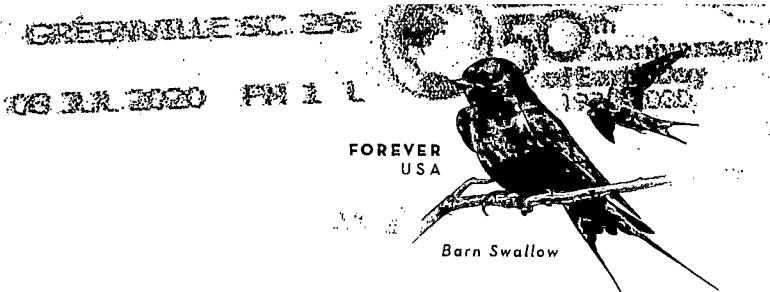
