## ORDER

---

Petitioner has filed a notice of appeal<sup>1</sup> from the Court of Appeals' opinion in *Kurowski v. Hawk*, Op. No. 2020-UP-145 (S.C. Ct. App. filed May 20, 2020),<sup>2</sup> which this Court has construed as a petition for a writ of certiorari under Rule 242 of the South Carolina Appellate Court Rules (SCACR).

Under Rule 242(a), SCACR, this Court will only review a final decision of the Court of Appeals, and a decision is not final for the purposes of review until a petition for rehearing has been acted on by the Court of Appeals. Rule 242(c), SCACR. Since no petition for rehearing has been ruled on by the Court of Appeals in this matter, there is no final decision for this Court to review.

Accordingly, the notice of appeal is dismissed without prejudice to petitioner's right to serve and file a petition for a writ of certiorari and appendix in the manner provided by Rule 242, SCACR, should the Court of Appeals deny any petition for rehearing.
