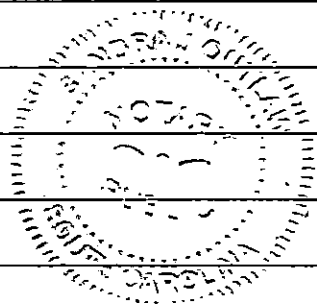
Appellant requests this production on

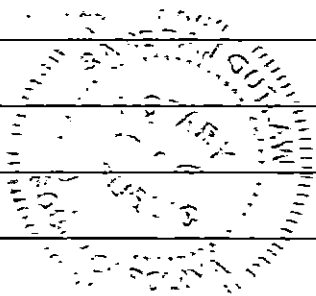

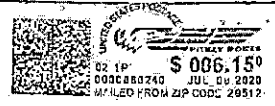
