

A check for the filing fee accompanies this motion.



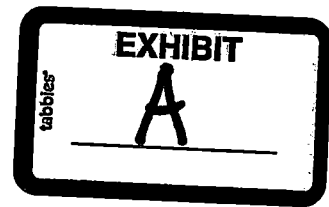



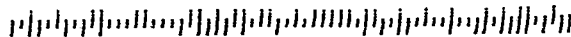
