Dear Ms. Kitchings;

I am contacting you today in regard to the above captioned case. A Probable Cause Hearing was had in Charleston County on April 27, 2020, in which I was represented by Attorney James Kristian Falk, Esquire. The Judge granted the state's order and a supplemental order was amended on May 14, 2020. I recieved a copy of both orders on June 8, 2020. The record indicates that I was represented by Attorney Falk, and once I understood that the judge ruled in the state's favor, I specifically informed Attorney Falk that I wish to appeal.

After a period of time had elapsed and I still had not received a copy of the notice of appeal from attorney Falk, I submitted a timely notice of appeal along with a proof of service to the Attorney General's Office, in which it was recieved by their office and stamped and filed dated June 18, 2020. See attached copy. On June 22, 2020 and July 6, 2020, I recieved letters from your office indicating that a proff of service has not been provided showing that notice of appeal was timely served and that attorney Falk had (10) days to correct the error. I recently was able to speak to attorney Falk via, phone, and was advised by him that he had no intention of filing my requested notice of appeal and that he was going to submit a motion to the Court conceding to the dismissal of my appeal. At this time I still have not recieved a copy of the notice of appeal along with a proof of service wich the Court instructed in the June and july letters addressed to him. I respectfully request that the Court take Judicial Notice of my attempt to presered my right to appellate review.



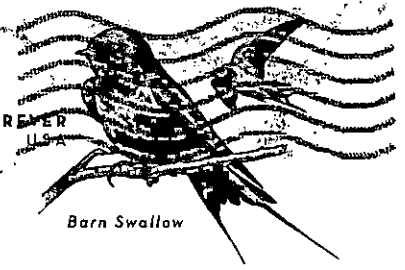
