
2. Appellants believe the challenges presented to the US Postal Service during this PANDEMIC may be the cause as to why Appellants did not receive the Court's ORDER.



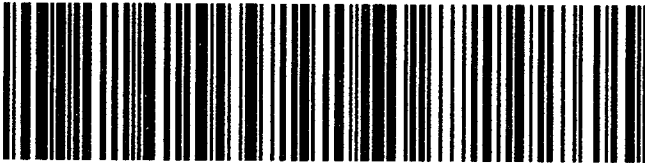
