Thank you for your response related to this issue. I have included a copy of the letter for reference by others on copy.


First, your letter asks me to complete the attached Transcript Request Form, but no Transcript Request Form was included in the letter. The contents of the envelope were composed of the letter included in this letter and a copy of my letter dated 6 July 2020.

Second, your letter states "Our records reflect that the proceedings that day were held in our digital courtroom". In regards to this statement,

1. Please explain. I was physically at the Charleston County Courthouse on 27 January 2020. Typically when I hear the words such as digital and virtual, I take that to mean not in the same physical place with the other parties. The physical environment on 27 January 2020 appeared to me to be very much almost identical to other occasions I have had to go to the Charleston County Courthouse for similar proceedings. Between these two facts, I'm obviously a bit confused.
2. Second, you didn't provide the name of the court reporter. Was there a court reporter assigned to Cole and Charleston County that day? If not, please clarify this process to the degree required.

Once again, thank you for finally helping with this situation and I look forward to a response as well as a copy of the Transcript Request Form. I will probably mail it in so everyone is kept in the loop related to eventually solving this problem.



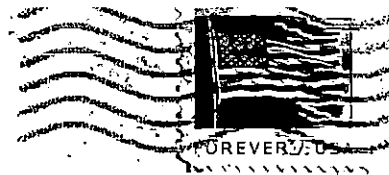
