Petition to Correct Volume II of the Record on Appeal

Counsel for the appellant petitions this Court for an order allowing him to correct Volume II of the Record on Appeal. This petition is based on the following grounds.

1) On May 15, 2018, counsel for the appellant filed the Record on Appeal. Volume II of the Record ended on page 737. Volume II should end on page 797. Counsel for the State called this error to the attention of counsel for the appellant.


