Please allow this letter to serve as a response to your July 8, 2020 letter concerning the above matter. At present I do not have any conflicts with the possible oral argument dates set out in your letter, including November 2, 3, 4, 5, 10, and 12.

However, I should note that I have a multi-party, 3-week federal jury trial in the United States District Court for the Western District of North Carolina (*Rhyme v. U.S. Steel, et al.*, 3:18-cv-197), which is expected to be scheduled sometime between September–December 2020 (and which may, therefore, conflict with the dates set out in your letter). The trial date will be definitively set following a July 24, 2020 status conference. I will follow up with additional conflict information after that status conference, but I am reporting the above currently-known information now to comply with the Court’s request to receive conflict information by July 22.

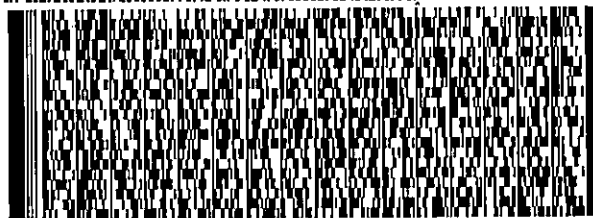

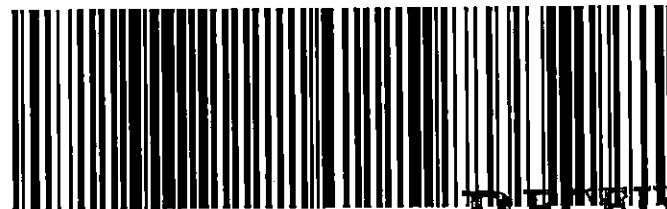
