NOW COME, Melissa Duque, who being duly sworn, does hereby attest to the following facts in the above-captioned matter:

1. I was appointed by the Clerk of Court to handle the above referenced matter for Francisco Saul Ortiz Aguirre. This appeal is part of a guilty plea on May 18, 2020.
2. I am an Assistant Public Defender for Beaufort County Public Defender's Office.
3. I am filing this appeal upon the request of my client, Francisco Saul Ortiz Aguirre.
4. I am not aware of any reviewable appellate issues as a result of this plea. However, at the request of appellant, I am filing this appeal. Mr. Ortiz Aguirre's concern is that he pled to three counts of Burglary 2nd Degree (Non-Violent); four counts of Forgery, value \$10,000 or less; one count of Petit Larceny after receiving presentment to the Grand Jury.
5. Furthermore, Mr. Ortiz Aguirre feels that though the sentences imposed were between range, the sentences were unduly harsh and excessive for a first time criminal offender who does not have a prior criminal record, and in this factual scenario, he should have not received the maximum sentence of (10) ten years for each of the three Burglary charges, (5) five years for each of the four Forgery charges, and (30) days on the Petit Larceny charge.

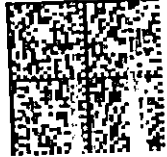
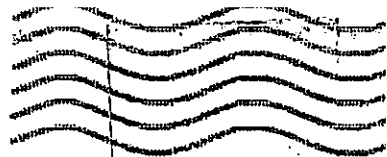

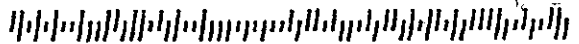
