4. my parents are deceased and my Grandmother Martha Phillips caregiver for Amy and myself . In the year of 2016 my Grandmother was dying on her death bed : I received a settlement my cousin Amy Phillips Cabbagestalk and her husband Reginald Cabbagestalk started plotting on myself. I told Amy about the police misconduct also the feared for my safety and Xavier. Amy ask me for money and I told her No.

Amy called my uncle Ennis Phillips and Aunt Bonnie said that I was crazy. I was stating that the cops was going to kill me. Also that i didn't know my name address and who i was. I spoke with my uncle Ennis that stated my aunt Bonnie was getting some kind of papers. I personally asked him what in the world was he talking about but he wouldn't tell me. * I knew it was over my settlement* I never left Xavier with my mothers family because of all the abuse from my childhood. THANKS SC.

5. I Angel Phillips wreck my vehicle in Goldsboro with my 15 teen year old son under distress from the Darlington county city police department also the be on the look out !!!! yes i was freaked out and in fear for my young son. My boy had seen and heard to much for his young pure heart from immoral political corruption. I was lost in the woods for two days from the stress blacking out ,didn't eat for days before the accident three day lost no water or food.I was going through all stages of dehydration. I was in the shadows of death. so much fear and confusion before leaving SC. political corruption from Darlington city police. so I prayed asking Jesus not to hand me over to evil men. If its my time on earth is up please send supernatural guides to take me to the throne room of Jesus Christ. I also ask him to forgive SC and NC because they know not what they have done. Bloodthirsty men eager to shed the blood of the innocent for their own evil sins.

6. Goldsboro Police department stated to Wayne Memorial Hospital that i was running through the woods naked , offering sexual favors to a road worker. (This is what the darlington city done to me). Defamation of character civil wrong I was in fear looking for help. The road work had line of cars stop and I run through the cars in fear. Never spoke to anyone at all. someone also says I Angel don't like to follow maps . I just go where I want to. I don't care if the exits says A or B. I was going through all stages of dehydration. Dr.Goodwin also give paper work to sign over my personal financial records. I asked her why does the hospital want me to sign over my financial records? I was told my family give her the paperwork. NOT my brothers but aunt and uncles. my brothers call me at the hospital and was on the way to pick me up so i could go home. But the hospital let people without legal right mark me private. so then my brothers told me they didn't know where i was or what happen to me at this point. Dr.Godwin drug myself with med for paranoid schizophrenia also placing this dialogues into my personal med records. That i'm paranoid schizophrenia to cover braking med laws this is malpractice and just evil. when i came home i

was unable to function because of the wrong med. I also a bad vaginal bleeding , I have felt like I was dead but still ALIVE FOR LAST PASS THREE YEARS. Dr.Goodwin also lied stating that i was combative ready and eager to fight!!!!

Fight who i lived in fear ? Be honest I had all rights too be in fear and confused. The Human brain and body can only take so much stress also trauma before it starts to break down.

9. I'm informed that my child has been turn over to Department Hartsville social services over my car accident that was cause by political corruption. illegal paper from NC police the apartment and SC psychotic lies to entrap a black gay women that's innocent not guilty of any crime or offense. my Cousin Amy Phillips Cabbagestalk call the Department Hartsville social service lied stating that neglect my son to other family member that work for DSS , I wouldn't have die first.* All over money * Amy told me this on a hospital call in NC. I was so confused once again hurt fear so much pain. At this I just wanted to go back with my kid. But, now he's been taken from me over evil people wrong doings. Amy didn't have a home of her own . My boy had no where no sleep. Amy husband Reginald is felon that give my son a gun to shoot in their care. I never abandoned my son the DSS case was un-found in SC *NOT TRUE ONCE AGAIN*

I had to file police reports because still until today. I'm being victimized by Amy husband Reginald Cabbagestalk to the point now given his own teenage son guns but Darlington county know that. case number 201910-0304 / second case number 202006-0978 because of SC Not doing their jobs like investigate discover and examines the facts. political corruption.

10. PTSD post -traumatic stress disorder still in treatment.
11. After coming to back home to SC from NC : I had to come home to dealing with the Department of Child Services in Hartsville SC. With No understanding why my kid was living with Amy and Reginald Cabbagestalk over simple car accident for *neglect*. so, STATE OF NORTH CAROLINA BROKE MY CIVIL RIGHTS WITH A INVOLUNTARY COMMITMENT ORDER DATED 06/20/16 CUSTODY ORDER FOR WHAT !!!!

WE CAN'T BREATH TAKE YOUR KNEES AND HANDS OFF OF AFRICAN AMERICANS NECKS, WE HAVE A VOICE AND OUR BLOOD SHOULDN'T HAVE TO BE SHED FOR OUR VOICE TO CRY OUT FROM THE GRAVE.

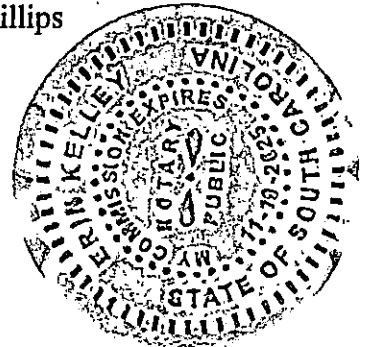
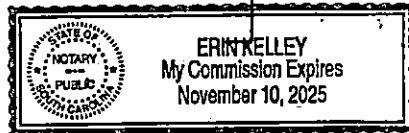
