I represent the Respondent in the above-referenced appeal. On May 27, 2020, I submitted a Motion to Dismiss Appellant's Appeal for failure to receive the transcript within the time allotted and failure to notify the appropriate personnel of the delay. The Court denied the motion, but issued a letter dated July 9, 2020, providing that Appellant must serve and file their initial brief and designation within thirty days. Appellant subsequently informed the Court by letter dated July 13, 2020 that he believes the delay in receiving the transcript may be due to the fact that he is unaware of where the Court Reporter, Thelma Salters, is currently working.
