I have not received information regarding this courts deficiency corrections informing me as to which appeal this case refers to. Judging from your ORDER, your ORDER is in regards to a Notice of Appeal I filed with this court from a memorandum from the Administrative Law Court (ALC), and that you are dismissing my Notice of Appeal because the memorandum is not a final order--which is incorrect. I request extra time in the amount of 30 days assuming you need an amount by your rules in which I currently have no access to without adequate law library. In support of my claims I declare under penalty of perjury the foregoing is true and correct.

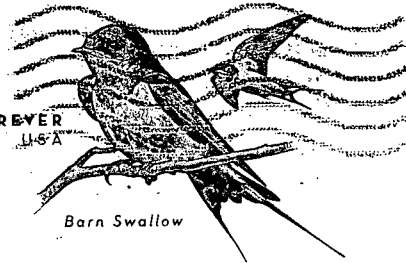
