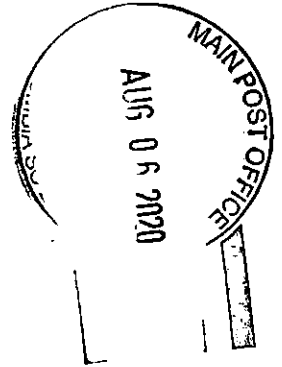


DECLARATION IN SUPPORT OF MOTION TO BE HEARD



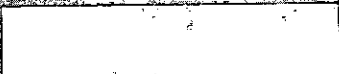
