

NOTICE OF APPEAL

Defendant Marquez D. Glenn appeals his denial of statutory immunity pursuant to S.C. Code Ann. § 16-11-410 et seq. and his conviction and sentence in this case. The sentence was imposed by the Honorable John C. Hayes, III on August 5, 2015. After successful appeal to the Supreme Court, this case was remanded for rehearing on the issue of statutory immunity. The denial of immunity by the Honorable Letitia Verdin was filed on June 15, 2020. Appellant received written notice of entry of this order on July 6, 2020. Appellant timely filed a motion pursuant to Rule 29(a), SCRCrimP, requesting reconsideration of various points of law and fact, which was denied on July 28, 2020. Appellant received written notice of entry of this order on August 5, 2020 and now appeals therefrom.


