RESPONSE TO MOTION TO DISMISS

The order granting summary judgment on the Respondent’s renewed motion for summary judgment was filed on April 30, 2020. Counsel for the Appellant was hospitalized with a serious illness from April 24 – May 5, 2020 during which time he underwent three surgeries. Following discharge from the hospital counsel was under the influence of heavy intravenous and other medications and was essentially incapacitated. See affidavit of counsel attached as Exhibit 1.

The Motion to Alter or Amend the order of April 30, 2020 was filed on May 27, 2020. Judge Gibbons was aware of counsel’s medical condition. Based on Judge Gibbons’ e-mail (see Exhibit 2) counsel assumed that Judge Gibbons excused the late filing of the Motion to Alter or Amend pursuant to Rule 60(b)(1), SCRPC and then denied the motion “on substantive grounds” rather than the procedural ground of untimely filing. Moreover, the Court of Appeals, pursuant to Rule 60(b)(1), SCRPC may grant relief from the late filing under these circumstances, which clearly qualify as mistake, inadvertence or excusable neglect. Furthermore, the Supreme Court’s

order on March 20, 2020 extended the due dates for filings by 20 days and forgave any procedural defaults. The Appellant should not have its appeal dismissed under these circumstances.

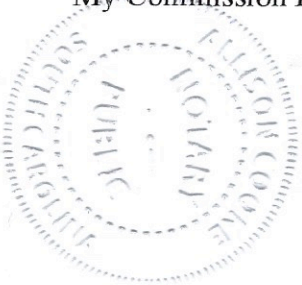


