He did not answer my questions at this time. He had anal pain with defecation but it has improved. On this examination there were no abrasions, tears or erythema. The rectum were normal. There was no anal dilation. The patient did not provide a disclosure with me. He did disclose with the forensic interview. His initial examination was with Levine's Children Hospital. The result of this examination reveals a 5 five year old male, who was shy and did not provide a disclosure. He was apprehensive about the examination, but was reassured by his mother.

His examination was at this time without signs of injury or inflammation. This represents interval healing from his examination that occurred 2 days after the event.

When the officers asked the mother when she thought this may have happened she stated that she was not sure but she thought it might have happened sometime last night 9-18-2010. The child could not tell the officers when it happened.
