Following the Order vacating the Judgment by Magistrate's Court, Appellant-Defendant filed a Motion for Costs under S.C. Code §18-7-220 and Rule 54(e), SCRPC. The Court finds that Appellant-Defendant is entitled to costs, but just for those costs associated with this appeal and not the prior appeal. Therefore, costs awarded are as follows:

(1) Filing Fee for Appeal \$180.32; (2) Transcript for March 2020 hearing \$708.05; (3) Copies \$22.40; and (4) Motion fee \$31.74. Therefore, Appellant-Defendant is awarded Costs of \$942.51 against Respondent-Plaintiff.
