
Pursuant to SCRCP 5(d) and SCACR 262, Appellant informs the Court that the Respondent's Certificate of Service is inaccurate and service upon Appellant was not proper. Pursuant to Court Rules, it may be acceptable for certificates of service to be submitted to the court after completion of service, but certificates of service should not be submitted to the court falsely certifying that service is complete when it is not.
