Attorney's Fees and Costs



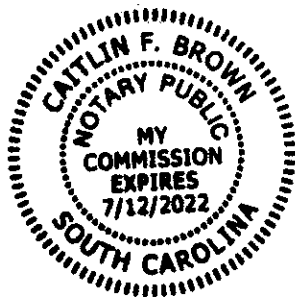


