Dear Ms. Kitchings,

I am responding to Appellant's letter to you, dated August 25, 2020, which I received today, six days after the reported date, wherein he alleges I filed a false Certificate of Service with this Court.

Throughout this case and beginning in the trial court, Appellant routinely makes false accusations about my character. When doing so in writing, he fashions his accusations to be placed in the record. It is hard to know how to respond given the conduct is aberrant and appears intended to provoke and defame. Prior to today, I have not responded to any of the allegations but I am unsure if that is the best course.

In April of 2015, the U.S. Postal Service announced a slow-down in delivery of first class mail. Recent post office difficulties are widely publicized. For the past two years, I routinely receive mail in which the postmark and certificates do not match. Sometimes, there is no post mark at all. In fact, I never received the January 13, 2020 letter Mr. Griffin mentioned in his correspondence to you, but I do not assert it was due to fraudulent practices when there are other plausible explanations.

The Certificate I filed with this Court reflects the day the items were deposited in the outbound mailbox at my office complex. The complimentary email mentioned therein was delayed by two days which the email message openly admits.

If appropriate, please place this letter in the record as my response. If this Court requires additional information from me, please feel free to contact me.

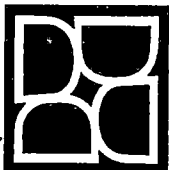

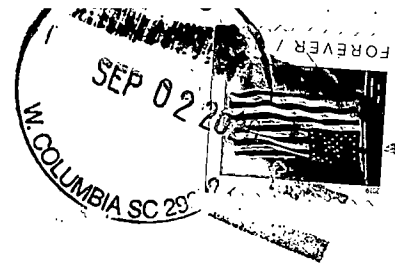
