This letter is in response to the September 9, 2020, letter from Jake Moore, counsel for the Town of Irmo, requesting the Town of Irmo be added as a respondent in the above referenced appeal. The Town was not a party to the proceeding in the Public Service Commission that gave rise to the referenced appeal. Accordingly, the Town is not a respondent pursuant to SCACR Rule 202(a) and is not a party to this appeal.

There was a subsequent similar proceeding in the Public Service Commission (Docket No. 2019-290-WS) for which the Town of Irmo did intervene and actively participate. There will likely be an appeal from that proceeding but the Commission's order on reconsideration has not yet been issued. No notice of appeal has been filed for the subsequent proceeding.

We request that the Town's request to be added as a respondent to Appellate Case No. 2020-000266 be denied.
