**AMENDED NOTICE OF APPEAL**

---

The South Carolina Department of Employment and Workforce appeals the following Orders of the Honorable Doyet A. Early and the Honorable Clifton B. Newman:

1. Order of the Honorable Doyet A. Early dated April 29, 2016 and filed May 5, 2016, certifying class.

2. Order of the Honorable Doyet A. Early dated April 12, 2017 and filed April 27, 2017, denying reconsideration of the Order of Judge Early dated April 29, 2016, and holding that Plaintiffs Bollerman and Patterson have standing to represent the putative class.

3. Order of the Honorable Doyet A. Early dated October 27, 2017, which (a) denied reconsideration of the Order of Judge Early dated April 12, 2017, and (b) further denied reconsideration of the Order of Judge Early dated April 29, 2016.

4. Order of the Honorable Doyet A. Early dated and e-filed February 15, 2019, and attached Notice to Class Members, ruling in favor of Plaintiffs on the merits, and making additional rulings.

5. Order of the Honorable Doyet A. Early dated and e-filed March 11, 2019, denying both parties' motions to alter or amend, except on the issues raised by Plaintiffs' motion regarding the notice to the class, the class definition, and the claims made process established in the February 15, 2019, order, those latter issues being taken under advisement.

6. Order of the Honorable Doyet A. Early dated and e-filed March 21, 2019, and attached Notice to Class Members, granting Plaintiffs' Rule 59(e) motion regarding the claims made procedure and class definition. Appellant received written notice of that Order when it was e-filed on March 21, 2019, and

originally filed a Notice of Appeal of that and all Orders referenced above on April 8, 2019.

7. The South Carolina Department of Employment and Workforce (now Appellant/Respondent) also appeals the Order of the Honorable Clifton B. Newman dated July 20, 2020 and e-filed July 22, 2020, denying reconsideration of the Order of Judge Doyet A. Early dated March 21, 2019. Appellant/Respondent received written notice of the entry of Judge Newman's Order when it was e-filed on July 22, 2020.



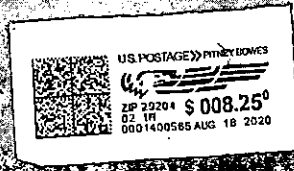
