This letter is to request an extension of time to comply with the filing of the initial brief in this matter until October 1, 2020. The reasons for this request are:


1. That on August 3, 2020 the undersigned suffered a stroke and has been under a doctor's care and in fact has been hospitalized for medical procedures intermittently during this month.



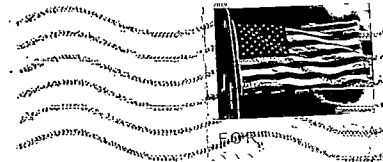
