
**MOTION FOR COSTS AND





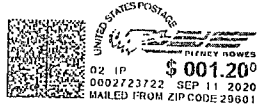
