I've got copies of all of them as a matter of fact I've got copies of everything from the 1st day I came to prison. I'll be very prepared to represent myself (pro se) if I'm not released on the first of September 2020 Tuesday of next week. I've written Ms. Hackett asking her basically the same thing I'm

" You. Isn't it time I get released after all this time I've done for no crime being committed by me? In case you don't which yard/prison I'm in it's Kershaw and I'll also need a bus ticket to Augusta Georgia. Please find the time to help clear this nightmare of a time I've been having over these last 6 years of my life to be overwith and done. This state has taken enough from me hasn't it? I just need to go home and visit my mother's grave is that asking to much? Thank you

can you will you respond back to me

to come and pick me up from the
