I had to call Parkway village office Apartments office due to a water leak in my hallway. The hot water heater had to be replaced today. The time of my call to the emergency maintenance line was at 10:06 am.

The maintenance man Ronald was inside my apartment, after speaking with me this morning. Maintenance said the hot water heater would have to be replaced. He then told me in front of my state provided nurse aide help. That he had to go to Lowe's himself and pick up a hot water heater. My nurse aide help from the state took me to the store to get some drinks the local gas station 1.8 of a mile from my apartment. When I return maintenance man Ronald was outside with his water removal equipment, and also a new hot water heater. My nurse aide left after bringing my drink inside from her vehicle. She was done for her work with me for the day until tomorrow. When I came inside I am very nauseous due to the fact I'm in a severe amount of pain. I am currently under a doctor's care I having to have surgery upcoming that will be 6 to 8 hours long to repair my severely damaged spinal cord.

I am not supposed to be lifting any more than 3 lb very mild walking under a doctor's care. I had clothing store Dove my mother's curtains of my mother's stored in the closet where the storage area is. The hot water heater is in that closet. Half of the closet area was empty of items. I was told by Ronald I needed to get my stuff out of the closet. There are heavy items I am not supposed to physically lift. I was told by my doctor 3 of my five herniated disc or at a slant very ready to rupture themselves. I was told to take it very easy still under my surgeon's care. This maintenance man proceeded to tell me after the nurse left out of the apartment to start removing my stuff that he will not remove it. Maintenance man for Parkway village office Apartments proceeded to remove the leaking hot water heater. All of my items were not yet out of the closet. I was trying to remove my items as fast as possible. Mr Ronald began pulling out the hot water heater getting water rust and mud all over my clean clothing. Some of the clothing stored and items stored in the closet

belong to my deceased mother. I have every reason to believe it was intentional of him to do what he did today . All of the work the nurse has helped me with getting my apartment back in order has been all in vain this week. The maintenance man also put a small hole in the wall of the closet area wow bringing in or bringing out the old and new hot water heaters. I requested he please fix that hole please can he help me all of my items are wet and soiled with rust and water . I was in my apartment alone trying to move as fast as I could to get my items out before he unloaded all of the water onto them in the closet. I have every reason to believe he broke the law by videotaping taking photographs of my apartment without my knowledge or consent. I am asking the court to help me . I went to the office as jacquetta Elias the parkway village office Hartnett management pulled up to the front of the office roll her window down said to me I'm not going to argue with you Lisa. I've been asked her to please give me a laundry card to wash my things right away that were so oiled . She told me no she will not give me a laundry card that I need to ask Jane Henderson . Jane Henderson is the boss of jacquetta Elias. Jane Henderson works for Westminster company corporate office. Miss Jane Henderson herself has told lies on me which will be presented in the upcoming brief. I am in a very lot of pain still yet have not had breakfast at this very given moment. Now they have brought more stress on to me with the mess I have everywhere I am including photographs of my items strong about wet things outside of been trying to get dried. Maintenance man Ronald began his work replacing the hot water heater. Water got everywhere mr. Ronald pulled out the hot water heater from area in the closet pouring water all over the things I had not yet gotten up out of the walk-in closet. As I stated earlier I asked management to please give me a laundry card where there is a small laundry room on the property to get my soiled items clean right away. I was denied told no I'm not going to argue with you Lisa talk to Jane. This is a letter a plea to the court to please intervene. I am asking the court to please grant me peace of mind to know that know of the maintenance men be allowed in my apartment for any repairs again. I am also pleading with the court to please allow an outside contractor for any other repairs be done be billed to Westminster company corporate please. I have had to file police report for unlawful entry of one of the maintenance men John Bentley just this month. I have not yet picked up that police report from my County I reside in. I did call the Berkeley County Sheriff's Department Officer Garcia responded to the call came out seeing all my damaged water still in the closet with rust in the floor. All of my please no avail no avail. They are intentionally hurting me more and more. I am tired of the harassment from the management, and then neglect of my disabilities in the state of South Carolina. I am pleading with the court today to please grant that Parkway Village management nor their maintenance team be allowed in my apartment. I am also pleading with the court that I'd be able to change my locks myself for the deadbolt lock of my choice. I don't want any of this management nor do I want their maintenance men back in my home. I am requesting with the court to please intervene with this letter please help me. I am under a doctor's care and a lot a lot of pain, and under a lot of stress. Please please I am pleading with the court to please help me with my current situation this is my letter of plea to the court to intervene. I have been harassed by residents, and management for two years now. Please intervene case number 202-000-0629. I am enclosing a few photographs for this letter. Officer Garcia Berkeley County Sheriff's Department stated this is a civil matter. It is more than a civil matter I have been harassed neglected of my disabilities on multiple occasions from the current management. Please please I'm begging pleading with the court to intervene allow me to change my locks allow me to have peace of mind knowing that they cannot come into my home while I am at many upcoming doctor visits.
