For archival quality, all forms & releases must be submitted in their ORIGINAL form, signed in **DARK INK** and **free of any white-out or correction tape.**
5. If you receive any correspondence from the Court, please read and review the information and the deadline imposed. Contact your Judicial Assistant immediately if you do not understand any of the documents or if you cannot meet your deadline. If deadlines are missed without cause, you can be summoned to Court and/or personally fined for dereliction of duties.
