In response to your letter dated August 24, 2020, saying my counsel Robert Dudek submitted a petition for Writ of Certiorari my appeal is without merit and moves to be relieved as my counsel; I ask the Court for patience as you take the time to read this letter as I explain and respond to your letter, everybody involved with this case have taken the oath of their office but nobne wants to do their job that they swore to uphold; when I felt that some -thing was wrong with my case, from that day and moment I had ask -ed to have a jury trial as my 6th Amendment right. I'm suppose to have been granted a trial if I wish to have my accusers present; I had turned down this plea for over a year because I didn't burg -larize the residence I went to; there was no forced entry; I was let in the house by Gary Forshee an occupant who was there; after I knocked he peeped-out the window and let me inside; as far as the plea I hadn't been out of the hospital a good month from being in the ICU for eleven (11) days due to two slight Strokes and a slight Heart attack where they had to revive me twice and my Public Defender knew that; I had been out on bond for over a year and I didn't take nor accept that plea then... why would I take and accept that plea now; she used my sickness to her advantage and took advantage of me because instead of helping me she was steadily calling me on my cellphone telling me that I better take the plea and that I was facing a life sentence for a burglary I

didn't commit; she knew I wasn't well and in my right mind just coming out of the hospital, I was under duress. I told her I wanted another attorney because she wasn't trying to help me, and she told me the judge wouldn't give me another attorney because I had her too long; she constantly and continued to nagged me and saying the same thing over and over about I better take that plea, because of that, I was forced to take a plea for the First Degree Burglary at an illegal crack house where I was beaten and robbed; she was ineffective as my counsel; she didn't help me in no way but as I had mentioned just kept telling me I better take the plea; the same people who had helped the plaintiff Ricky Bullock that had beaten and robbed me left the scene before the police got there but those same people came to Court for Ricky Bullock and I had pointed that out to her, so that, she could have gotten their names and subpoena them and they were never subpoenaed to come to Court or was never questioned; I just want what I deserve by the law, a fair trial and a chance to prove my innocence with my own attorney; as far as my PCR trial to where they say I didn't have my witnesses present when I was told my PCR would be held in Marlboro County and that's where they (my witnesses) went; my PCR attorney for the Attorney General Office, Sherill Alford didn't tell the Judge I was suppose to have my PCR hearing in Marlboro County because the Attorney General had requested to the Clerk of Court of Chesterfield County that my PCR be held in another county because of alot of corruption in my case, so this is why my witnesses were at Marlboro County because I was getting letters from that day telling me my PCR would be held in Marlboro County instead of Chesterfield County, this is why my witnesses were in Marlboro County, the right place but I was at the wrong courthouse; I couldn't contact them to let them know that I was at Chesterfield County Courthouse; I suppose to be in Marlboro County according to my paperwork; there's so many things that went wrong in my case; I just want what's promised to me, a full bite of the apple, a fair trial with my accusers present; I just want justice and I

appreciate your patience to take the time to read this letter.

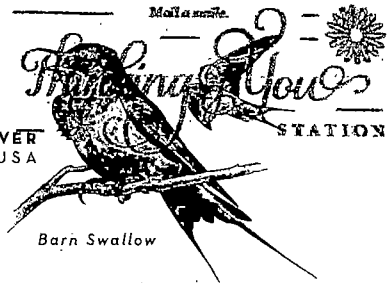
