MOTION FOR EXTENTION OF TIME

ADDENDEM


I, Ashley Tucker, Appellant, respectfully request an extension of time pursuant to SC Rule 240(a). Appellant has made attempts to get the court reporters to release the transcripts for the entire case since March 19th, 2020. Counsel Elizabeth Blackwell stated that Every Word Production was the company that she hired for all of my court appearances. When I contacted Every Word Production, I spoke to a guy named Dale who at first stated that they did not have any other court proceedings outside of a September 2016 and October 2019 transcript. Around September 9th, 2020 I contacted Every Word Production in another attempt to locate all of my transcripts. Dale informed me that they in fact do have a transcript from June 17th, 2019 but it was notated that the witness was not present so the court reported left. Dale also stated that after further investigation they found out that the June 17th preceding was recorded but wasn't ordered by Counsel Elizabeth Blackwell. I was told that they needed additional time to transcribe the court proceeding for June 17th, 2019. I have attached proof of contact with Counsel Elizabeth Blackwell on numerous occasions as she continuously affirmed that Every Word Production handled all of my cases, which was false information. Counsel Elizabeth Blackwell intentionally gave me incorrect information because she ordered the December 3rd, 2019 transcript from AWR. The December 3rd transcript is the proceeding I was referring to in our emails that could not be found.

I contacted the courts on numerous occasions over the past year in attempts to gather information which the Clerk or Court didn't have anything on file. The Clerk of Court stated on numerous occasions that Counsel Mrs. Blackwell hired the court reporter and that I would need to contact her. I called the court last week and spoke to a Ms. Megan who gave me AWR's information but stated she couldn't make any promises that the reporter who was present that day was actually the reporter who handled my case. When I called AWR, I spoke with a lady by the name of Kristen and provided her my case number, and stated she didn't have a transcript with that case number on file. Afterwards, I emailed Ms. Kristen to gather evidence that she didn't have any file pertaining to my case. Shortly after my initial email, I received an email reply stating that AWR did have a transcript on file for my case and that Counsel Elizabeth Blackwell had previously obtained transcripts from them. Counsel Elizabeth Blackwell knew and purposely hid the information from me throughout the entire duration denying me my right to due process of law.

Please see the attached email from Counsel Elizabeth Blackwell dated December 3rd 2019, stating that she requested all my transcripts for my case and that EVERY Word Productions handled all my transcripts.

Lastly, to add to my request for an extension, I just had back surgery on 8/27/2020 and need some additional time to heal. Please see the attach email from Every Word Production requesting time to transcribe the record. Also, see the attached proof of my medical records pertaining to my surgery.
