MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF



Counsel filed the Initial brief of appellant and designation of matter in the case of The State of South Carolina v. John Ira Duncan III with the Court of Appeals on September 10, 2020. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Shiquan Tyon Cwiklinski v. The State of South Carolina with this Court on August 25, 2020. Counsel filed the Initial brief of appellant and designation of matter in the case of The State of South Carolina v. Kenneth Wayne Carlisle with the Court of Appeals on August 25, 2020. Counsel filed the Initial brief of appellant and designation of matter in the case of The State of South Carolina v. William Shane Fordham Brown with the Court of Appeals on August 21, 2020. Counsel filed the petition for rehearing in the case of The State of South Carolina v. Michael N. Frasier, Jr. with the Court of Appeals on August 13, 2020. Counsel filed the Anders brief of appellant and designation of matter in the case of The State of South Carolina v. Courtney Brock with the Court of Appeals on August 11, 2020. Counsel filed the petition for rehearing in the case of The State of South Carolina v. Steven Barnes with the Court of Appeals on August 6, 2020. Counsel filed the petition for rehearing in the case of The State of South Carolina v. Johnathan Green with the Court of Appeals on August 5, 2020.

4. Counsel makes this request in good faith and not for purpose of delay.


5. Opposing counsel, the Attorney General's Office, has graciously consented to this extension request by way of the thirty day general consent granted by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through October 31, 2020. That emailed general consent was dated September 28, 2020.

WHEREFORE, the undersigned counsel would respectfully request a thirty day extension, in which to file the petition for writ of certiorari and appendix in this case based upon the above exigent circumstances. Counsel requests that time limits for filing the petition be held in abeyance pending a ruling on this motion.
