MOTION TO EXTEND TIME TO FILE REPLY BRIEF

Pennsylvania National Mutual Casualty Insurance Company, by and through counsel, and pursuant to South Carolina Rule of Appellate Procedure, Rule 208(a)(3) and Rule 240, moves the Court to extend by Fifteen (15) days the time to file its Reply Brief and shows the Court as follows:

1. Pennsylvania National Mutual Casualty Insurance Company (“Penn National”) filed a Notice of Appeal on April 22, 2020, appealing from a Judgment that was entered on behalf of two separate parties, the Persimmon Hill HOA and Portrait Homes-South Carolina, LLC and Portrait Homes—Persimmon Hill, LLC (collectively “Portrait Homes”).

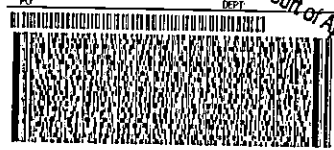
