


**MOTION FOR CONTINUANCE TO FILE SUBSTITUTION OF COUNSEL

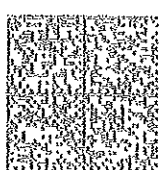

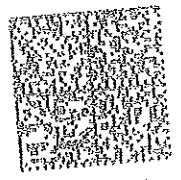
