C. I, James Reese, am of an elderly age and have been limited in my per-pandemic travels and public outings due to the ongoing COVID-19 pandemic.



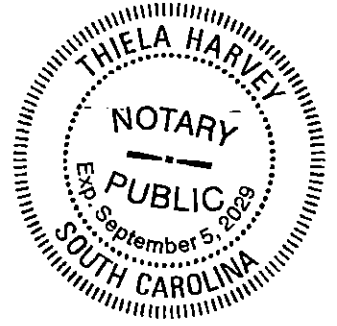

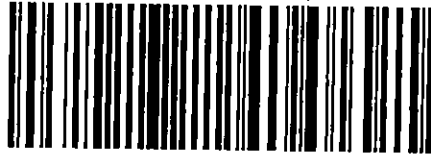
