2 GREGORY GREEN: [enters room]

3 DETECTIVE JELLICO: Hey, get [inaudible] man, [inaudible]

4 GREGORY GREEN: I need to go to the restroom.

5 [crosstalk]

6 DETECTIVE JELLICO: Hey, can y'all--can y'all take him to
7 the bathroom, right up there. While I get some other stuff.

8 Y'all searched him down real good, right?

9 [all parties leave room]

10 GREGORY GREEN: [enters room]

11 DETECTIVE JELLICO: [enters room] Real quick, I've got
12 to get another search on you Gregory. Turn around for me.

13 [searches Mr. Green]

14 GREGORY GREEN: [inaudible]

15 DETECTIVE JELLICO: This is your cash?

16 GREGORY GREEN: I got cash right here too. That's

17 [inaudible]

18 DETECTIVE JELLICO: It's like an inside pocket?

19 GREGORY GREEN: Yeah. [crosstalk] [inaudible]

20 DETECTIVE JELLICO: Okay.

21 GREGORY GREEN: [crosstalk] weed. This is bullshit.

22 DETECTIVE JELLICO: Open up your mouth for me. Take off
23 your shoes. Kick both feet up here to me. [searches legs]

24 GREGORY GREEN: So much bullshit boy, [inaudible] my
25 momma's [inaudible]

1 DETECTIVE JELLICO: All right. [searches shoes]

2 GREGORY GREEN: [inaudible] come and they call me and
3 this nigga say, [crosstalk]

4 DETECTIVE JELLICO: Greg, I don't even know what the hell
5 this is about.

6 GREGORY GREEN: I already got an idea, so much
7 bullshit, times two.

8 DETECTIVE JELLICO: Uh huh.

9 GREGORY GREEN: Word. I'm not trying to be in here.
10 For me to be in this right here and talk to a Detective.

11 DETECTIVE JELLICO: Stand up one more time for me. Face
12 that wall.

13 GREGORY GREEN: [crosstalk]

14 DETECTIVE JELLICO: Stretch your feet as far as that will
15 let you. [inaudible], okay?

16 GREGORY GREEN: Yeah, I don't have shit.

17 DETECTIVE JELLICO: Okay.

18 GREGORY GREEN: [crosstalk, mumbling]

19 DETECTIVE JELLICO: \$20, \$40, \$60, \$70, \$80, \$90. Sound
20 right? \$99. [puts money in Mr. Green's pocket]

21 GREGORY GREEN: [inaudible] pocket on the left, side
22 pocket.

23 DETECTIVE JELLICO: Make sure you tell them about your
24 inside pocket whenever you [inaudible]

25

1 GREGORY GREEN: I'm gonna tell the person downtown.

2 [inaudible]

3 DETECTIVE JELLICO: [crosstalk] man.

4 GREGORY GREEN: Fuckin'--[inaudible]

5 DETECTIVE JELLICO: Oh, you were trying to get

6 [inaudible]

7 GREGORY GREEN: The motherfuckin' police car

8 [inaudible] [crosstalk] motherfucker with an SK—not an SK, an

9 AR.

10 DETECTIVE JELLICO: Yeah.

11 GREGORY GREEN: That's what that shit looked like.

12 DETECTIVE JELLICO: Right.

13 GREGORY GREEN: That's crazy bro.

14 DETECTIVE JELLICO: Okay.

15 GREGORY GREEN: This is some real life bullshit

16 though. Everybody act like they ain't know what's going on

17 but the whole—this bullshit dog.

18 DETECTIVE JELLICO: Well, somebody's going to come in and

19 talk to you in a couple of minutes, okay.

20 GREGORY GREEN: Just tell them to come holla at me,

21 all right. This is bullshit.

22 DETECTIVE JELLICO: [leaves room]

23 GREGORY GREEN: [to himself] This is a bunch of

24 bullshit. On my momma, this some fuckin' [inaudible]

25 bullshit. [pause]

1 [Detectives enter room]

2 DETECTIVE JELLICO: What's up my man. I don't care about
3 that little crack you left in the bathroom.

4 GREGORY GREEN: Little crack? What crack in the
5 bathroom?

6 DETECTIVE JELLICO: The crack they got.

7 GREGORY GREEN: Crank?

8 DETECTIVE JELLICO: Crack?

9 GREGORY GREEN: When?

10 DETECTIVE JELLICO: You're on video in there, you know
11 there's a video in that bathroom, right? That--

12 GREGORY GREEN: Yeah, but if there's a video in the
13 bathroom, I used the bathroom to take a piss. [crosstalk]

14 DETECTIVE JELLICO: Yeah. I'm not worried about that.

15 GREGORY GREEN: I ain't worried about that shit
16 either.

17 DETECTIVE JELLICO: That's why that bathroom is not used
18 by anybody except people up here is because--

19 GREGORY GREEN: I understand that, but [inaudible] I
20 was using the bathroom.

21 DETECTIVE JELLICO: Right and it also shows the crack.

22 GREGORY GREEN: [inaudible] I forgot I had it in my
23 drawers. I forgot. All the weed and shit [crosstalk]

24 DETECTIVE JELLICO: I ain't worried about it. What did
25 you do with all the weed, I don't want to know where it is.

1 GREGORY GREEN: [crosstalk]

2 DETECTIVE JELLICO: Where did they pick you up at?

3 GREGORY GREEN: Downtown at my aunt's house.

4 DETECTIVE JELLICO: They went downtown to get you?

5 GREGORY GREEN: Uh huh.

6 DETECTIVE JELLICO: Where at downtown?

7 GREGORY GREEN: Congress Street.

8 DETECTIVE JELLICO: Damn. I didn't know that. All the
9 way downtown.

10 GREGORY GREEN: You ain't the detective I talked to
11 the last time, [crosstalk]

12 DETECTIVE JELLICO: I don't think so. When did you call
13 me? You know, we got a bunch of--

14 GREGORY GREEN: They called me.

15 DETECTIVE JELLICO: We called you?

16 GREGORY GREEN: Yeah.

17 DETECTIVE JELLICO: I don't think I talked to you.

18 GREGORY GREEN: Somebody called me.

19 DETECTIVE JELLICO: What's your first name?

20 GREGORY GREEN: Green, Gregory.

21 DETECTIVE JELLICO: I don't think so. [inaudible] I
22 ain't going to lie to you, I could've talked to you and don't
23 know. But I don't think so. [pause] But we need to talk
24 today.

25

1 GREGORY GREEN: Yeah, we need to talk for real
2 because this a bunch of bullshit.

3 DETECTIVE JELLICO: You got the paper?

4 DETECTIVE: Yeah, you want-

5 DETECTIVE JELLICO: Yeah, I want to get that.

6 DETECTIVE: Okay. [leaves room]

7 DETECTIVE JELLICO: I can't answer everything, so I
8 brought one of the files in here, you know what I mean. So,
9 if you ask me [inaudible] you been around the block, all
10 right. I read you your rights. I can't answer questions,
11 right off the bat, you got to give me time to look in this
12 folder, you follow what I'm saying? To be fair. Because I'm
13 going to let you ask questions too. But, I don't want it to
14 be like-I'll look, if you see what I'm saying, you feel me on
15 that. I'll look and if I can find it in here-some of this
16 stuff is at the lab. So, I won't have, I'll just tell you
17 it's at the lab. That means, I don't know what the lab is
18 going to say, bad, good, indifferent, I don't know, that means
19 slippery slope, you know.

20 GREGORY GREEN: I ain't worried about none of that
21 shit because I ain't did shit.

22 DETECTIVE JELLICO: Well--

23 GREGORY GREEN: That's crazy.

24 DETECTIVE JELLICO: That was your-who was that-you said
25 something to the boys about, you think we did your cousin?

1 GREGORY GREEN: Yeah man. Listen-listen, [crosstalk]
2 DETECTIVE JELLICO: Yeah, that's what I'm saying.
3 DETECTIVE: [enters room]
4 DETECTIVE JELLICO: Before we go, let me do this. All
5 right. Let me see your tat. Pick it up, I can't see it.
6 GREGORY GREEN: [inaudible]
7 DETECTIVE: What's your date of birth?
8 GREGORY GREEN: [REDACTED] 81.
9 DETECTIVE: What's the highest level of school
10 you completed?
11 GREGORY GREEN: [inaudible]
12 DETECTIVE JELLICO: What school you go to around here?
13 Did you go to school around here?
14 GREGORY GREEN: No--
15 DETECTIVE JELLICO: North Charleston High?
16 GREGORY GREEN: Brentwood.
17 DETECTIVE JELLICO: Brentwood.
18 GREGORY GREEN: High School, yeah.
19 DETECTIVE JELLICO: All right. Read me the first right
20 on this form out loud.
21 GREGORY GREEN: I have the [inaudible] right to be
22 silent. I do not have to answer any questions or give a
23 statement and this fact cannot be used against me.
24 DETECTIVE JELLICO: Do you understand that?
25 GREGORY GREEN: Yeah, I understand that.

1 DETECTIVE JELLICO: He'll read the rest of it to you.

2 GREGORY GREEN: I already know all my rights.

3 DETECTIVE: Let me read them to you.

4 GREGORY GREEN: I know what going on. I got the
5 right to remain silent. I do have questions, if I do answer
6 questions or give a statement, anything that I say can be used
7 against me in a court of law. I have the right to consult a
8 lawyer of my choice before I answer questions or give a
9 statement and also, have him/her present when I'm being
10 questioned. Which, I tried to call my lawyer, my lawyer
11 already not know what going on. He supposed to be—he going to
12 be at the bond hearing, so this is—I wish to talk to my
13 lawyer, I'm unable to hire attorney, one will be appointed to
14 represent me free of charge. If I decide to answer questions
15 or give a statement without having a lawyer present, I have
16 the absolute right during the interview to stop questions and
17 remain silent. I already know all that man, I ain't
18 [inaudible] shit.

19 DETECTIVE JELLICO: All right. I know, that's what I'm
20 saying, [inaudible]

21 GREGORY GREEN: This is all bullshit to me. Come on,
22 pick up the story.

23 DETECTIVE JELLICO: You got to sign the bottom portion if
24 you want to talk.

25 GREGORY GREEN: Oh my god.

1 DETECTIVE JELLICO: You want a water.

2 GREGORY GREEN: Yeah, something to drink man.

3 DETECTIVE JELLICO: [leaves room]

4 GREGORY GREEN: I mean, yeah, I can answer questions,
5 but I don't-ain't too much fuckin' information I can tell you.

6 DETECTIVE: Okay. Well, we can work-

7 GREGORY GREEN: [crosstalk] I got to read-why I got
8 to sign on the bottom?

9 DETECTIVE: That's-you don't have to, he said you
10 can and that basically said that your willing to talk to us
11 right now.

12 GREGORY GREEN: I'll talk to y'all right now, but I
13 ain't-[inaudible] because that's crazy because [inaudible]
14 talk about-

15 DETECTIVE: Well, that's okay. That's all it's
16 saying is that you're willing to talk.

17 DETECTIVE JELLICO: Why did you scratch it out?

18 DETECTIVE: Because he wants to revoke it.

19 GREGORY GREEN: I ain't trying to revoke nothing.

20 DETECTIVE: [crosstalk]

21 DETECTIVE JELLICO: Do you want to talk or not?

22 GREGORY GREEN: Well, we can talk.

23 DETECTIVE JELLICO: I can't talk without this. I mean,
24 if you want to waive your right.

25

1 GREGORY GREEN: Shake it off. I ain't talking—I
2 ain't waiving no rights. I want to know what the fuck going
3 on.

4 DETECTIVE JELLICO: That's what this means. This means
5 you're waiving your right—you're not giving them up. That
6 don't mean that.

7 GREGORY GREEN: I understand that. I just want to
8 know why I'm sitting in here. I already know why I'm sitting
9 in here but that shit is dumb to me.

10 DETECTIVE JELLICO: Which one? What part? The crack
11 part or the other part?

12 GREGORY GREEN: Y'all gonna charge me with the crack?

13 DETECTIVE JELLICO: No. I ain't looking at it, so I
14 don't want to.

15 GREGORY GREEN: That's crazy man, a little bit of
16 crack.

17 DETECTIVE JELLICO: Talk to me about your cousin.

18 GREGORY GREEN: All right, my fuckin' cousin.
19 Angelo, called me about the situation. After that shit
20 happened.

21 DETECTIVE JELLICO: Okay, [inaudible] him.

22 GREGORY GREEN: You know what I'm saying. The man
23 called me, like there was something the night before, whatever
24 the fuck happens because I done heard all different kind of
25 stories to what happened. I heard somebody died in a fire and

1 then I heard somebody killed a fuckin' man. [inaudible] I
2 live right there, across the street.

3 DETECTIVE JELLICO: Okay.

4 GREGORY GREEN: My old man live damn near across the
5 street and that's where I was staying at. The man don't fuck
6 with nobody. The man don't do shit. The man dying any
7 fuckin' way. A lot people don't even fuckin' know that, so
8 why kill him man? Who gonna die anyway. What justification
9 or reason would I have to kill my own fuckin' cousin?

10 DETECTIVE JELLICO: What's he got, sickle cell or
11 something?

12 GREGORY GREEN: He got [inaudible]

13 DETECTIVE JELLICO: Oh, okay. I didn't work this case--

14 GREGORY GREEN: No, I'm saying--

15 DETECTIVE JELLICO: [crosstalk]

16 GREGORY GREEN: --family [inaudible] that shit dog.

17 This man [inaudible] our house, why the fuck I'm gonna kill
18 this man for? The man owe me like \$60, on the 1st.

19 DETECTIVE JELLICO: The 1st of the month?

20 GREGORY GREEN: The month. Yeah. The man owe me
21 like \$60. The man usually owe me like \$100 and some change.

22 DETECTIVE JELLICO: So, he routinely owes you money and--

23 GREGORY GREEN: Yeah, every-every [inaudible] to the
24 house. He comes to the house [inaudible], so I mean like, I
25 don't understand this shit man. This shit is dumb to me.

1 Kill my fuckin' cousin. That's my mom—god rest her soul, my
2 momma favorite nephew. My momma raised him. He raised me.

3 DETECTIVE JELLICO: How old [inaudible] how old are you?

4 GREGORY GREEN: Like, 50 something. My mom was
5 [inaudible] and then that's when [inaudible] my mom was so
6 close because he's like 20 years younger than my mom. So,
7 them boy close.

8 DETECTIVE JELLICO: When he was—when the house caught
9 fire that night, right, where was you at? At your daddy's
10 house or whatever?

11 GREGORY GREEN: When the house caught the fire that
12 night, I don't know when the house caught fire. I know when I
13 left from downtown.

14 DETECTIVE JELLICO: Well, I mean, you just know when it
15 happened, that's what I'm saying. Where were you at?

16 GREGORY GREEN: [crosstalk] Home, [inaudible]

17 DETECTIVE JELLICO: Where was home? Downtown?

18 GREGORY GREEN: No, on [inaudible] right damn near
19 across the street.

20 DETECTIVE JELLICO: Okay.

21 GREGORY GREEN: [inaudible] I been downtown on
22 Congress Street. That's where I be at, downtown, doing my
23 thing and I catch a cab up the road.

24 DETECTIVE JELLICO: When did you hear about it?
25

1 GREGORY GREEN: No, when I heard about it? When I
2 jumped in the cab, that morning, and saw all the fuckin'
3 lights down the street. I didn't know what was going on. And
4 then, my sister called and been like, that's Angelo. Angelo
5 died in a fire. That's so much bullshit. I mean, on my momma
6 grave, I've done a lot of fucked up shit in life, that ain't
7 one of them. I wouldn't do no shit like that.

8 DETECTIVE: So, that night, you were downtown,
9 down on Congress.

10 GREGORY GREEN: Down on Congress. Then I left
11 downtown and came up the road. I stopped to the club and I
12 went home.

13 DETECTIVE: And, what club did you stop at?

14 GREGORY GREEN: The Bistro at Rivers, I stopped by
15 the Bistro, because matter of fact, yeah—that night when the
16 fire happened, that's when [inaudible] they got the twerk
17 contest shit going on.

18 DETECTIVE JELLICO: Uh huh.

19 GREGORY GREEN: [inaudible]

20 DETECTIVE: About what time was that, did you go
21 home from the twerk contest?

22 GREGORY GREEN: [pause] It had to been like almost
23 around 2:00, right before that shit ended.

24 DETECTIVE: And then you went back to the house.

25 GREGORY GREEN: Yeah, I walk home.

1 DETECTIVE: And that was it for the night?

2 GREGORY GREEN: That—I ain't go nowhere else that
3 night. Not to my recollection.

4 DETECTIVE: Okay.

5 GREGORY GREEN: I get me a [inaudible] the only thing
6 I can remember was, [pause] the night when this shit happened—
7 because early that morning, I had to go [pause] where I went
8 to. Either Walmart or CVS, one of them shits because I had to
9 get wipes, early that morning. That's when the next thing you
10 know, [inaudible].

11 DETECTIVE: What time did you go to Walmart or
12 CVS or whatever you said?

13 GREGORY GREEN: No, I went downtown. I went
14 downtown, so I went to CVS. That was like, psst, early in the
15 morning, like 7:00, 8:00, 6:00, 7:00, no 7:00. No, it was
16 between 7:00—yeah, between 6:00 and 7:00 because the sun was
17 just coming up. Yeah.

18 DETECTIVE: So, you left Azalea and went down
19 there?

20 GREGORY GREEN: I went downtown. I was supposed to—I
21 didn't go to CVS myself, I sent somebody to CVS. They had a
22 bike. When I got out of the car, [inaudible] Killian Street
23 [phonetic] they went down to CVS. Mr. George went to CVS for
24 me because that's [inaudible] I be having him do shit for me.
25 He ended up going to CVS, get the wipes. He came back with

1 the wipes. I sat down and smoked like three blunts. Cashed
2 my little \$100 [inaudible] like I usually do, which I was on
3 the way to go catch just now, that's why that's [inaudible]
4 right there. That's it.

5 DETECTIVE: So, that day, just so I got it
6 correct from what you're telling me, at 6:00 in the morning,
7 you're down-downtown over on Killian.

8 GREGORY GREEN: Yeah. I went from Killian to
9 Congress Street. That's how I do every fuckin' night man.

10 DETECTIVE: So, at 2:00 in the morning, you leave
11 the club. You go down to your house on Azalea and then what
12 time did you leave for Killian?

13 GREGORY GREEN: Like, 6:00, 7:00, between 6:00 and
14 7:00.

15 DETECTIVE: All right. Because the way you said
16 it a minute ago, I understood you to mean that you left
17 Killian to go to the store, and that was at 6:00 in the
18 morning.

19 GREGORY GREEN: I left to go downtown, like Mr.
20 George—I ain't going to put nobody on blast, but the man be
21 stealing and shit. So, all the wipes and shit I get, I get
22 like four, five pack of wipes from him, for going in. He hits
23 CVS hard, so.

24 DETECTIVE: Okay. All right.

25

1 GREGORY GREEN: I mean, that's being cheap, you know
2 what I'm saying.

3 DETECTIVE: Right. Right. All right. So, that
4 morning, that's where you were. You heard anything as to what
5 this—what this whole thing—how this went down?

6 GREGORY GREEN: Man, the only fuckin' thing I heard
7 is a man—first thing is a man died in a fuckin' fire. All
8 right. Somebody tell me, he already just had a house fire not
9 to long ago or whatever. So, [pause] It been a couple of
10 days later, she called me reading some shit off from the Post
11 and Courier saying that he got shot. You get what I'm saying.

12 DETECTIVE: Okay. So, did he get shot, before?

13 GREGORY GREEN: I ain't never knew nothing else to
14 happen to him. Dude just—

15 DETECTIVE: He's never had this kind of trouble
16 with anybody.

17 GREGORY GREEN: Dude don't fuck with nobody man.
18 That's a real life big dude, all he like to do is fuck with
19 fat girls, bro.

20 DETECTIVE: Gotcha.

21 GREGORY GREEN: I'm telling you [inaudible] this man
22 going [inaudible] he like to fuck with fat girls.

23 DETECTIVE: Gotcha. Did he already have a drug
24 problem? Did he use?

25

1 GREGORY GREEN: Yeah, he used to use drugs, but he,
2 used to buy weed from me. [inaudible] now.

3 DETECTIVE: Okay. Did he routinely buy from you
4 or deal with anybody else?

5 GREGORY GREEN: He was fuckin' with them little boys
6 around that side, them little boys who got—what they call they
7 self? Um. [pause] Damn, what the fuck they call they self.
8 [inaudible].

9 DETECTIVE: Gotcha.

10 GREGORY GREEN: All right. That's they little area.
11 They little section where he stay at. All them, [inaudible]
12 drive all that shit, [inaudible] and he would tell me about
13 him getting locked up on—after he [inaudible] something, for
14 some crack.

15 DETECTIVE: Okay.

16 GREGORY GREEN: That shit [inaudible] like he said,
17 it's safer for him to deal with me because he come straight to
18 the house.

19 DETECTIVE: Right.

20 GREGORY GREEN: He ain't got to—

21 DETECTIVE: Deal with them out on the street.

22 GREGORY GREEN: You know what I'm saying?

23 DETECTIVE: Yeah, yeah, yeah.

24 GREGORY GREEN: And, that's [inaudible]

25

1 DETECTIVE: He'd usually pay you on the 1st of
2 the month?

3 GREGORY GREEN: First or the 3rd of the month.

4 DETECTIVE JELLICO: So, you'd front him.

5 GREGORY GREEN: Yeah.

6 DETECTIVE JELLICO: Because he was family, I got you.

7 GREGORY GREEN: You know what I'm saying.

8 DETECTIVE: So, you always took care of him. You
9 made sure he had his stuff.

10 GREGORY GREEN: Always. He always took care of me.

11 DETECTIVE: Okay.

12 DETECTIVE JELLICO: How did he take care of you?

13 GREGORY GREEN: He raised me.

14 DETECTIVE JELLICO: Okay, gotcha. I know you told me
15 that.

16 GREGORY GREEN: He raised me. That's my momma's
17 favorite nephew.

18 DETECTIVE: Gotcha.

19 GREGORY GREEN: Because they damn near the same age,
20 but that's her nephew. So, he more like an uncle to me than a
21 cousin.

22 DETECTIVE: Right.

23 GREGORY GREEN: Always [inaudible] all my fuckin'
24 life. This shit right there is pitiful. This shit right
25 there, I really, really [inaudible] man.

1 DETECTIVE JELLICO: Why do you think people would bring
2 up your name?

3 GREGORY GREEN: Why would people bring up my name?

4 DETECTIVE JELLICO: Right, we didn't pull your name out
5 of a hat. In other words, do you know what I'm saying, why
6 would people be saying that you would've [inaudible] shoot
7 your cousin?

8 GREGORY GREEN: Why would people—why would a
9 motherfucker say I shot my cousin anyway?

10 DETECTIVE JELLICO: That's what I'm getting at. Why
11 would somebody out there be doing that?

12 GREGORY GREEN: No. Somebody out there, whoever the
13 fuck that is, they need to get a life. That shit sound like
14 some—one of my babymommas would do. Because my cousin
15 [inaudible] got killed in front of the store [inaudible] and
16 the whole street, everybody in the street, I had something to
17 do with that. How the fuck I got something to do with my
18 cousin getting killed. This is the second fuckin' time. And,
19 it wouldn't be no surprise if motherfuckin' her ass behind
20 this shit now.

21 DETECTIVE JELLICO: Behind Foots [phonetic]

22 GREGORY GREEN: Behind this shit.

23 DETECTIVE JELLICO: Right. We solved Foots murder,
24 didn't we?

25 GREGORY GREEN: On the fuckin' [inaudible] but--

1 DETECTIVE JELLICO: Yeah.

2 GREGORY GREEN: That's what she tellin' people in the
3 street, I had something to do with that shit.

4 DETECTIVE JELLICO: I know you didn't because I worked on
5 Fooths.

6 GREGORY GREEN: You know what I'm saying. I had, but
7 that's what she pushed in the street. So, some other shit
8 happened with my other cousin, she saying the same thing.
9 [inaudible] That shit ain't got nothing to do with me.
10 [inaudible]

11 DETECTIVE JELLICO: I know it wasn't no woman—I gotta
12 stand. This damn chair. You can put your shoes back on, man.

13 GREGORY GREEN: I ain't try to--

14 DETECTIVE JELLICO: What gets me is, I can tell you this,
15 it wasn't no girl, from what I was told, that said this.
16 That's why I'm kind of—I can see that passion for your cousin.
17 You feel me with that right?

18 GREGORY GREEN: [crosstalk] All right.

19 DETECTIVE JELLICO: I see that passion. So--

20 GREGORY GREEN: What—what is the fuckin' gain from
21 this shit man?

22 DETECTIVE JELLICO: That's what I'm asking—you gotta help
23 me [crosstalk]

24 GREGORY GREEN: --for me to kill my fuckin' cousin?

25 DETECTIVE JELLICO: Well--

1 GREGORY GREEN: [inaudible] he dying any fuckin' way
2 man.

3 DETECTIVE JELLICO: Right. [inaudible]

4 GREGORY GREEN: [crosstalk] my brother this shit,
5 that's why there's nothing out, [inaudible]

6 [crosstalk]

7 GREGORY GREEN: That shit stupid man. I wouldn't do
8 no dumb ass [inaudible] Word, that's fuckin' dumb. That shit
9 senseless to me.

10 DETECTIVE JELLICO: Now--

11 GREGORY GREEN: I tried to put two and two together
12 with that shit.

13 DETECTIVE JELLICO: See, because at the same time we have
14 to clear you, you know what I mean, and work through dumb
15 stuff, so to speak--

16 GREGORY GREEN: Exactly.

17 DETECTIVE JELLICO: --to get to where we need to be.

18 GREGORY GREEN: Answers. Because [stutters]
19 Answers. It don't make no fuckin' sense. Why you [inaudible]

20 DETECTIVE JELLICO: Your other shoe is under there.

21 GREGORY GREEN: That shit is dumb.

22 DETECTIVE JELLICO: The other thing is, you know, when
23 you and your cousin--you fronted him a little bit. Obviously
24 he didn't smoke that much.

25 GREGORY GREEN: No.

1 DETECTIVE JELLICO: Because--

2 GREGORY GREEN: The man smoked, but he smoked

3 [inaudible]

4 DETECTIVE JELLICO: How much--how much--

5 GREGORY GREEN: Weed.

6 DETECTIVE JELLICO: [crosstalk]

7 GREGORY GREEN: The man would come get a dime, or a
8 dime and dime. A dime of crack and a dime of weed.

9 DETECTIVE JELLICO: So, he's a little nickel-nickel
10 stuff.

11 GREGORY GREEN: You know what I'm saying, smoke the
12 little booty man. The man didn't fuck with nobody. The man--
13 the man fuck with his dog and a big dog and fat girls, dog.
14 That's crazy:

15 DETECTIVE: Did you go over there occasionally to
16 see him?

17 GREGORY GREEN: I been over there.

18 DETECTIVE: You took him stuff, right?

19 GREGORY GREEN: One time, all right--have I been over
20 there to see him? Yes, I just had walked to my sisters

21 [crosstalk]

22 DETECTIVE: Well, I'm saying to you--

23 GREGORY GREEN: She live behind him on--what street
24 she live on. Cambridge, on the dead end side--not the dead end
25 side but--

1 DETECTIVE: I know what you're talking about-

2 GREGORY GREEN: But behind-so, one day I was walking
3 from there and he was outside with the dog and me and my
4 nephew stopped right there, you know what I'm saying.

5 DETECTIVE: Okay. I'm just asking if you-I know
6 he comes over to you a lot--

7 GREGORY GREEN: Yeah.

8 DETECTIVE: --but you don't go--

9 GREGORY GREEN: --I don't go in-his house nasty, I
10 been there one time.

11 DETECTIVE: His house is nasty?

12 GREGORY GREEN: Yeah, like he don't-I can't do it.

13 DETECTIVE: Okay. I was just curious, if you had
14 been there enough to know kind of who else frequents the place
15 and whatnot, but if you don't go there often.

16 GREGORY GREEN: The only time I ever go in there and
17 he-the little fuckin'-the fuckin', little trick [crosstalk]

18 DETECTIVE: So, you wouldn't know anybody around
19 that area that would know what's going on or anything.

20 GREGORY GREEN: No, like a little female, that would
21 probably be the only person. It was a white girl. I forget
22 her name. She been trying to talk to me and shit, but I know
23 her situation, so--

24 DETECTIVE: What's her situation?
25

1 GREGORY GREEN: No, I know his situation, so that
2 [crosstalk]

3 DETECTIVE JELLICO: Right, you knew you had to be the
4 [crosstalk]

5 GREGORY GREEN: Go through that shit.

6 DETECTIVE: You don't know a name from her?

7 GREGORY GREEN: A, some shit. She be out there on
8 fuckin' D Road--

9 DETECTIVE JELLICO: Walking all the time?

10 GREGORY GREEN: That's fuckin' retarded as fuck man.

11 DETECTIVE: So, there would be no other time that
12 you'd been over there enough to know whose there, who's in and
13 out?

14 GREGORY GREEN: No, because most of the time, he come
15 to me. Honestly and truthfully, you see where I been at,
16 where you caught me at, I be [inaudible] you know what I'm
17 saying. I don't deal with people like that. During the
18 daytime, I always on the inside.

19 DETECTIVE: Gotcha.

20 GREGORY GREEN: So, he'll come through, [inaudible]
21 carry on.

22 DETECTIVE JELLICO: So, if they had information—I didn't
23 really work, work this case the whole time, okay. If they had
24 information that you had been there that night, are you sure
25 you didn't go over there, just to see him?

1 GREGORY GREEN: No.

2 DETECTIVE JELLICO: Now, I ain't talking about doing it,
3 I'm talking about just going there.

4 GREGORY GREEN: No, I ain't even [inaudible]
5 [crosstalk]

6 DETECTIVE JELLICO: Help me with that, because that might
7 help us—

8 GREGORY GREEN: He called me for some weed, when I
9 been downtown. I ain't had no weed, so I told him, I ain't
10 have none. That was the last time I talked to him, like 11:00
11 last night.

12 DETECTIVE: And you ain't got your phone.

13 DETECTIVE JELLICO: What did you do with your phone?

14 GREGORY GREEN: The phone, that shit—I cracked the
15 phone, when I see the US Marshals outside, because I know
16 that's how they found me.

17 DETECTIVE JELLICO: They already got all that.

18 [crosstalk]

19 GREGORY GREEN: My phone don't even go to logs like
20 that because it's a [inaudible] phone.

21 DETECTIVE JELLICO: What is it, a Boost—

22 GREGORY GREEN: A flip phone.

23 DETECTIVE JELLICO: Okay, okay.

24 GREGORY GREEN: So, it don't even have the call logs
25 or nothing from—they ain't in there.

1 DETECTIVE JELLICO: So, we got to go to the subscriber.

2 GREGORY GREEN: Matter fact, look at him—look at his
3 cell call records. That's what the detectives told me.

4 DETECTIVE JELLICO: Well, everything is burnt the hell up
5 and they're coming in now.

6 GREGORY GREEN: No, the text—

7 DETECTIVE JELLICO: No, that's what I'm talking about,
8 they're coming in—matter of fact, you might have them.

9 GREGORY GREEN: The Detective called me.

10 DETECTIVE: [crosstalk]

11 GREGORY GREEN: --something, that's the only time I
12 was able to talk to him [crosstalk]

13 DETECTIVE JELLICO: So, basically, when we subpoena your
14 records, it should kind of match up.

15 GREGORY GREEN: Yeah, 11:00 something.

16 DETECTIVE JELLICO: And then, it should bounce off the
17 towers in the city.

18 GREGORY GREEN: Yeah, it's from the towers in the
19 city to whenever [crosstalk]

20 DETECTIVE JELLICO: See, I don't want to get you mixed
21 up, you know what I mean.

22 GREGORY GREEN: I understand that.

23 DETECTIVE JELLICO: And hem you up some kind of dumb
24 stuff.

25 GREGORY GREEN: No, no.

1 DETECTIVE JELLICO: Other people look at this and say-

2 GREGORY GREEN: It should bounce off the towers in
3 the city to Rivers and Reynolds to my [inaudible] or by our
4 house, where we live at. You get what I'm saying.

5 DETECTIVE JELLICO: Right, right.

6 GREGORY GREEN: He live damn near right across the
7 street. That shit retarded yo.

8 DETECTIVE: At the time-

9 DETECTIVE JELLICO: I've got to step out one second. I'm
10 coming back. [leaves room]

11 DETECTIVE: In the-in the morning you said you go
12 to Bistros, you leave, you go home.

13 GREGORY GREEN: Yeah.

14 DETECTIVE: You didn't leave home and then you
15 went--

16 GREGORY GREEN: I left like 6:00-my cab-the cab
17 driver [crosstalk]

18 DETECTIVE: Right.

19 GREGORY GREEN: Like, 6:00, that's when I came out.
20 When dude came out like 6:00 and that's when I went downtown.

21 DETECTIVE: So, there's no reason anybody
22 should've seen you or anything down on-on Bailey that night.

23 GREGORY GREEN: Ain't nobody-hell.no! Ain't nobody
24 see me on no motherfuckin' Bailey because I ain't been there.

25

1 DETECTIVE: Okay. And you're absolutely certain
2 of that.

3 GREGORY GREEN: Positively.

4 DETECTIVE: Okay.

5 GREGORY GREEN: [inaudible] I wish I had gone and
6 served [inaudible] maybe I could've stopped whatever the fuck
7 happened. I ain't been there.

8 DETECTIVE: Gotcha. That dog that's in there,
9 have you—have you interactions, you said it was a big dog.

10 GREGORY GREEN: Uh huh, pit bull. Every time I—we
11 was walking up [inaudible] he had the dog, he put the dog in
12 the house. You know what I'm saying, I don't even really too
13 much do—the one time—

14 DETECTIVE JELLICO: [enters room]

15 GREGORY GREEN: --that I walked—the only time I've
16 ever been in there, that shit nasty and shit man. I really,
17 weaseled my way out, you get what I'm saying. Like, yo—

18 DETECTIVE JELLICO: It stunk?

19 GREGORY GREEN: Yeah, like he—like, [inaudible] that
20 shit don't—

21 DETECTIVE: Yeah.

22 GREGORY GREEN: Because my momma cleaned it, I know
23 you a clean dude, you like dressing flashy and shit. Like,
24 that's all I know. Him—that nigga's great dog. That's a

25

1 great nigga. [inaudible] I can't see nobody doing that shit
2 to him. I can't see nobody-

3 DETECTIVE JELLICO: You can't see nobody flip-you know,
4 flip-get pissed-because he-did he have a mouth?

5 GREGORY GREEN: I mean, everybody got a mouth, but-

6 DETECTIVE JELLICO: I mean, like you know what I'm
7 talking about. Not knowing when to shut the hell up, be out
8 on the street talking to somebody and then-

9 GREGORY GREEN: No, he-he got an [inaudible] complex.

10 DETECTIVE JELLICO: That's what I heard about. I heard
11 [crosstalk]

12 GREGORY GREEN: Yeah, he got a [crosstalk]

13 DETECTIVE JELLICO: Some of the boys that I knew from
14 back in the North [inaudible] days told me that he would talk
15 to shit to them and they'd throw him all around.

16 GREGORY GREEN: This dude right here man, [pause] I
17 don't see nobody-because he's a low ass felon.

18 DETECTIVE JELLICO: Right, that's what I heard now.

19 GREGORY GREEN: You know what I'm saying, [crosstalk]
20 dog.

21 DETECTIVE: Right.

22 GREGORY GREEN: That shit crazy man.

23 DETECTIVE: So, if somebody said they saw you
24 there, what would you say to that?

25

1 GREGORY GREEN: Somebody say they seen me there, they
2 been lying because I ain't been there. Not that night right
3 there.

4 DETECTIVE JELLICO: That you were picked up by somebody
5 in a car.

6 GREGORY GREEN: No.

7 DETECTIVE JELLICO: Tell me if I'm wrong because I get
8 confused.

9 DETECTIVE: Uh huh.

10 GREGORY GREEN: No, I ain't been there. Ain't
11 nobody—why would somebody pick me up in the car, if I live
12 across the street?

13 DETECTIVE: I'm here to ask you—

14 GREGORY GREEN: Seriously.

15 DETECTIVE: I'm asking you.

16 GREGORY GREEN: I'm asking you. I live across the
17 street. Damn near—

18 DETECTIVE JELLICO: Who was home across the street that
19 night with you?

20 GREGORY GREEN: My wife. All my kids.

21 DETECTIVE JELLICO: How many kids you got?

22 GREGORY GREEN: Shit, I got 13 kids. I got—I got 13
23 kids and 10 babymommas. My wife was the only person that got
24 multiple kids. I just had a little boy [REDACTED], that's why
25 I been in the house and trying not to be outside. [inaudible]

1 street, too much shit been going on in the street.

2 [inaudible] to avoid getting killed.

3 DETECTIVE JELLICO: Anybody after you?

4 GREGORY GREEN: Man, listen. Ain't nobody after you
5 these days, motherfuckers just do dumb shit. You get what I'm
6 saying. People dying left and right for nothing. I ain't
7 trying to do none of that, people say that's [inaudible] be
8 inside. I did that shit in my past, I know motherfuckers in
9 my past probably still, oh that motherfucker, this that and
10 the third. I be to myself, I don't too much be mixing up,
11 none of that shit. [inaudible] or anything. I done
12 [inaudible] my story. My part of the story, which I know is
13 the truth. I just [inaudible]

14 DETECTIVE JELLICO: [inaudible] something about—this is
15 one I worked on. Do you remember Antoine Johnson.

16 GREGORY GREEN: [inaudible] What the fuck that got
17 to do with me?

18 DETECTIVE JELLICO: I'm just asking if you know him.

19 GREGORY GREEN: I know him. He from downtown. He
20 [inaudible].

21 DETECTIVE JELLICO: Where was he staying at?

22 GREGORY GREEN: On Terry Drive.

23 DETECTIVE JELLICO: Right. That's in [inaudible] right?

24 GREGORY GREEN: Uh huh.

25

1 DETECTIVE JELLICO: I get them mixed up now. He's
2 staying there.

3 GREGORY GREEN: That shouldn't-yeah, he was staying
4 right there, but he [inaudible].

5 DETECTIVE JELLICO: Remember dropping your flip phone?

6 GREGORY GREEN: No, I ain't never had my flip phone.

7 DETECTIVE JELLICO: No, this was [crosstalk]

8 GREGORY GREEN: Somebody stole a phone from me. So,
9 how can I drop a flip phone.

10 DETECTIVE JELLICO: When did they steal your phone?

11 GREGORY GREEN: Somebody broke in my car. Somebody
12 broke in my van outside my house.

13 DETECTIVE JELLICO: Did you call the police?

14 GREGORY GREEN: Huh?

15 DETECTIVE JELLICO: Did you call the police to tell them
16 about that?

17 GREGORY GREEN: No. We sold the van. They stole all
18 my clothes out the van but I-

19 DETECTIVE JELLICO: They stole your clothes?

20 GREGORY GREEN: Everything-I just had came back from
21 Atlanta.

22 DETECTIVE JELLICO: So, you remember when Banks got-Banks
23 got killed right?

24 GREGORY GREEN: Yeah, I heard about it.

25 DETECTIVE JELLICO: How did you hear about it?

1 GREGORY GREEN: The news and the streets. That shit
2 right there. The shit happened right there. That's crazy.
3 That ain't got shit to do with me.

4 DETECTIVE JELLICO: That one there--

5 GREGORY GREEN: And, that wasn't my phone.

6 DETECTIVE JELLICO: --that one there looked like it does.

7 GREGORY GREEN: No, I don't know what you talkin'
8 about. Not with that shit there. I ain't got shit to do with
9 that one.

10 DETECTIVE JELLICO: [inaudible]

11 GREGORY GREEN: I ain't been there period. I don't
12 have shit to do with that. Not-no. Uh-uh. I ain't been in
13 my cousin's shit either. But that one, no. Y'all can't do me
14 like that, I ain't been there. [pause]

15 DETECTIVE: It's-it's not as simple as just a
16 phone, you know.

17 GREGORY GREEN: [crosstalk]

18 DETECTIVE: These days, there's things like DNA.

19 GREGORY GREEN: Yeah.

20 DETECTIVE: There's fingerprints.

21 GREGORY GREEN: Yeah.

22 DETECTIVE: There's all kinds of stuff like that
23 that makes it a whole different thing.

24 GREGORY GREEN: I understand that and then, I ain't
25 been there so ain't no DNA. Ain't no fingerprints.

1 DETECTIVE JELLICO: Well, we got DNA at the scene. Now
2 I'm going to compare it to you.

3 GREGORY GREEN: All ~~right~~, that's what you do.

4 DETECTIVE JELLICO: That's what I'm going to do.

5 GREGORY GREEN: All right. That's all.

6 DETECTIVE JELLICO: [crosstalk]

7 GREGORY GREEN: That will clear me? Thank you.

8 Because I ain't been there.

9 DETECTIVE JELLICO: I don't know that it will clear you.

10 GREGORY GREEN: I ain't-

11 DETECTIVE JELLICO: Because we got some sealed
12 indictments [inaudible] and you're name is in one of them,
13 about that.

14 GREGORY GREEN: All right.

15 DETECTIVE JELLICO: But, that ain't what I'm here for
16 because I don't think you-this might be able to help yourself
17 because I know you ain't the shooter in that one.

18 GREGORY GREEN: I ain't nothing, period.

19 DETECTIVE JELLICO: I actually know-I actually like
20 [inaudible] -all this and the records and tires and
21 everything-that's gonna be-that's [inaudible] we been busy.
22 Have you not been watching the news? So, we ain't had a
23 chance to come up and get up on you.

24 GREGORY GREEN: That shit crazy dog.

25 DETECTIVE JELLICO: So, [sneezes]

1 GREGORY GREEN: [crosstalk]

2 DETECTIVE JELLICO: Excuse me. Huh, I can't hear you?

3 GREGORY GREEN: It's a murder though.

4 DETECTIVE JELLICO: You ain't—that dude, Banks, was a bad
5 dude.

6 GREGORY GREEN: He was and if anything happened to
7 him, I don't feel fuckin' sorry but I ain't do it.

8 DETECTIVE JELLICO: That's—listen to me on that, what I
9 say. I know you didn't do that. I know what happened to that
10 house was the boy—the other boy that—I gotta sneeze a boy,
11 don't—

12 GREGORY GREEN: I ain't worried about it.

13 DETECTIVE JELLICO: Yeah, but I don't wanna sneeze on
14 you. That's why I'm turning away. I know what happened
15 there. But—

16 GREGORY GREEN: [crosstalk]

17 DETECTIVE JELLICO: My problem is, how much do I hem you
18 up on that?

19 GREGORY GREEN: I ain't got shit to do with that
20 situation.

21 DETECTIVE JELLICO: You were there though.

22 GREGORY GREEN: No, I wasn't.

23 DETECTIVE JELLICO: Gregory.

24 GREGORY GREEN: Man, listen—

25

1 DETECTIVE JELLICO: Listen. Listen to me. You already
2 know, just think back in your head. Don't answer these
3 questions.

4 GREGORY GREEN: Uh huh.

5 DETECTIVE JELLICO: Think what I probably got. Quite a
6 bit. Matter of fact, this is one of two folders. I don't
7 know about you cousin, I went out to the house, it's burnt,
8 slapped the hell up. Then they shoot the dog too.

9 GREGORY GREEN: Do the what?

10 DETECTIVE JELLICO: Think they shot the dog.

11 DETECTIVE: I haven't gotten results back on the
12 dog. But, more importantly was the Chrysler that was
13 recovered that was used in that case.

14 GREGORY GREEN: The Chrysler.

15 DETECTIVE: And so, we know that the suspects
16 drove a Chrysler to that incident. DNA was recovered from
17 within that car that matches to Angelo.

18 DETECTIVE JELLICO: Remember what was used up the road?

19 DETECTIVE: And to the people that went there.

20 DETECTIVE JELLICO: Remember last time—you remember doing
21 them little stupid things, they put the cotton thing in your
22 mouth?

23 GREGORY GREEN: Yeah.

24 DETECTIVE JELLICO: You know what that's for, right?

25 GREGORY GREEN: DNA.

1 DETECTIVE JELLICO: Yeah, but you know how they do that,
2 right? Not just the DNA, there's more than that. There's a
3 thing called [inaudible] because I don't really know, it's
4 called CODIS. So, they take this swab and they like, go in
5 this—in the jail, in the penitentiary and they take it.

6 Now, what they do is like, all this is [crosstalk] from
7 scenes.

8 GREGORY GREEN: Yeah.

9 DETECTIVE JELLICO: It goes in its own computer thing.
10 So like, we go to a scene, that's how I know you was there and
11 they put all this stuff in because we [inaudible] little
12 cotton balls, we don't know who the hell and then the
13 computer—

14 GREGORY GREEN: [crosstalk]

15 DETECTIVE JELLICO: --and puts you there. Put it don't
16 put the gun in your hand, you follow what I'm saying.

17 GREGORY GREEN: [crosstalk]

18 DETECTIVE JELLICO: But it does put you there.

19 GREGORY GREEN: I ain't no mother—I shot one person
20 in motherfuckin' life and that's a person who kidnapped me
21 back in 19—no, that was 2002. You get what I'm saying. I
22 ain't no gun—[crosstalk] sell dope and weed, bro.

23 DETECTIVE JELLICO: You sell, you don't sell heroin?

24 GREGORY GREEN: I used to.

25 DETECTIVE JELLICO: Right.

1 GREGORY GREEN: I used to.

2 DETECTIVE JELLICO: Where did you get the—I don't want to
3 know a person, I'm just saying, where did you get it off of?

4 GREGORY GREEN: Off of—been a couple of people.

5 DETECTIVE JELLICO: No, I'm not talking about the people,
6 I'm talking about what area?

7 GREGORY GREEN: All over. All over. I been like—I
8 be all over. I be [crosstalk]

9 DETECTIVE JELLICO: I know that, I was saying—I was
10 trying to find, if you was going out of the city or if you was
11 getting it from [inaudible].

12 GREGORY GREEN: [inaudible] I be everywhere so it's
13 like—

14 DETECTIVE JELLICO: Now, the Terry thing, I talked to you
15 about that a little while, but that's something you need to
16 help yourself with because if I [inaudible] I can shoot you
17 something and you would be like, what the—because I know from
18 the other dudes that—we get into a lot of stuff, worked of
19 them a lot of them since then. I mean, it got you there. I
20 ain't got no gun in your hand because I know you—

21 GREGORY GREEN: I ain't been there bro.

22 DETECTIVE JELLICO: You was there because the damn DNA
23 don't lie bro.

24 GREGORY GREEN: The DNA?

25 DETECTIVE JELLICO: DNA has already came back.

1 GREGORY GREEN: [crosstalk]

2 DETECTIVE JELLICO: That's what I wanted to talk to you
3 about today. So, either I have to look at it and say, yo-
4 [crosstalk]

5 GREGORY GREEN: I couldn't tell you about that shit
6 because I don't know nothing about that [inaudible].

7 DETECTIVE JELLICO: And the Chrysler.

8 GREGORY GREEN: I don't know nothing about no fuckin'
9 Chrysler because I ain't did no shit to my fuckin' cousin dog.

10 DETECTIVE JELLICO: I didn't say [crosstalk]

11 GREGORY GREEN: That's crazy. You're saying the
12 Chrysler. They just [inaudible] Chrysler.

13 DETECTIVE JELLICO: That's what he's talking about.
14 [crosstalk] I don't know nothing about that.

15 GREGORY GREEN: That's what you said, right?

16 DETECTIVE: And that's the problem is we know the
17 Chrysler was there. We know—we know that. That's not even a-
18 a possibility or a-

19 DETECTIVE JELLICO: Let me get [inaudible] [leaves room]

20 DETECTIVE: --you know, an assumption, that's a
21 fact.

22 GREGORY GREEN: All right. The Chrysler, so what 'the
23 fuck the Chrysler--

24 DETECTIVE: And we know your DNA was there, in
25 the Chrysler.

1 GREGORY GREEN: My DNA was in the Chrysler?

2 DETECTIVE: So, if the car was there, people seen
3 you there and your DNA is there, that puts you there that
4 night.

5 GREGORY GREEN: Ain't nobody see me there and my DNA
6 can't be in no fuckin' car that I don't know nothing about.
7 Can you get me another water?

8 DETECTIVE JELLICO: [enters room]

9 GREGORY GREEN: I can get another water?

10 DETECTIVE JELLICO: I had to get the file on you. On
11 this case. This is my case. [inaudible]

12 DETECTIVE: So, the problem is, that's something
13 you can't deny. It's not--it's not--you can't change the facts
14 that you were there. Like he said, the thing that you can
15 change is the story that is unknown which is, who was there
16 with you at the time of the incident?

17 GREGORY GREEN: Man, I ain't been there and I don't
18 know what the fuck you talking about, whatever car you talk--I
19 be in a lot of people car. I be in a lot of fuckin' cars.

20 DETECTIVE JELLICO: You remember being in whatever car
21 he's talking about?

22 GREGORY GREEN: I don't know what--

23 DETECTIVE: You ain't never been in nobody's--

24 GREGORY GREEN: I done been in a lot of cars, man.

25 DETECTIVE: And that don't ring a bell.

1 GREGORY GREEN: My head really fuckin' hurting
2 because—psst, this shit crazy.

3 DETECTIVE JELLICO: Now, this one—this one is totally
4 separate from that one, okay.

5 GREGORY GREEN: I understand that.

6 DETECTIVE JELLICO: I don't want you to get me confused—
7 don't get me confused though.

8 GREGORY GREEN: I ain't getting confused about
9 nothing. I just ready to go in this jail and lay the fuck
10 down. This shit retarded, I can't call my lawyer, nothing.
11 This—y'all try to make me say I been somewhere the fuck I
12 ain't been, two times.

13 DETECTIVE JELLICO: No, I ain't talking about that. I
14 don't know nothing about that case there. I know about this
15 case.

16 GREGORY GREEN: Two times.

17 DETECTIVE JELLICO: I know about it. Remember I told
18 you, my name, Jellico, I got you all up Terry Drive.

19 GREGORY GREEN: Uh huh.

20 DETECTIVE JELLICO: All up.

21 GREGORY GREEN: I be on Terry Drive. I got

22 [crosstalk]

23 DETECTIVE JELLICO: I got you at that house. I got you
24 with Banks. I got your DNA in the house.

25

1 GREGORY GREEN: Uh huh, buddy I wasn't there.

2 [crosstalk]

3 DETECTIVE JELLICO: Let me ask you this.

4 GREGORY GREEN: I'm being honest with you bro.

5 DETECTIVE JELLICO: Yeah but let me ask you this.

6 GREGORY GREEN: I'm being honest with you.

7 DETECTIVE JELLICO: Okay.

8 GREGORY GREEN: Y'all might think I trying to shit
9 y'all or some shit. I a man, I man up wherever the fuck I be.
10 You're talking to me about [inaudible] talk to me about doing
11 some other shit like that. I'll tell you what the fuck I did.
12 I ain't did this shit bro.

13 DETECTIVE: So then, how is your stuff there?

14 GREGORY GREEN: Man.

15 DETECTIVE: How are you put there?

16 GREGORY GREEN: Y'all got to tell me how I being put
17 there.

18 DETECTIVE: No, I don't because I know you're
19 there. The problem is, that's the one part you're lying
20 about.

21 DETECTIVE JELLICO: Without-without getting all buggy and
22 everything, think about it like this. I don't-I don't-I can't
23 create DNA.

24 GREGORY GREEN: Who the fuck is that?

25

1 DETECTIVE JELLICO: That's just somebody else I been
2 talking to. You don't need to know about that.

3 GREGORY GREEN: [crosstalk] If you say that's in my
4 god damn file.

5 DETECTIVE JELLICO: Yeah, this is your file. But, I
6 can't put-make your doggone DNA.

7 GREGORY GREEN: I know, ain't nobody can't make my
8 DNA.

9 DETECTIVE JELLICO: You know what I'm saying?

10 GREGORY GREEN: I know where the fuck I been at and I
11 know where the fuck I ain't been at.

12 DETECTIVE JELLICO: Your middle name [inaudible] right?

13 GREGORY GREEN: Yeah.

14 DETECTIVE JELLICO: Boom, hit doggone, on your DNA.
15 Right there.

16 GREGORY GREEN: Hit on my DNA from off of what?

17 DETECTIVE JELLICO: We just told you.

18 GREGORY GREEN: I'm ready you to take me to County
19 man, because y'all are trying to make me fuckin'-that shit
20 crazy.

21 DETECTIVE: It's not like we held that
22 information from you. We told you exactly where that DNA came
23 from.

24 GREGORY GREEN: I know.

25

1 DETECTIVE JELLICO: So, what-now, Greg, this is what
2 you're telling me. Listen to me. This is what you're telling
3 me. Now, just hear me out on this, all right and then you-you
4 can do what you want to do.

5 GREGORY GREEN: My DNA is someplace where I ain't
6 even fuckin' been.

7 DETECTIVE JELLICO: Right. But-

8 GREGORY GREEN: Now, just like [inaudible] man, take
9 my cuffs and shit off right now and-

10 DETECTIVE JELLICO: They already did it.

11 GREGORY GREEN: That shit right there is not my DNA
12 from being in no fuckin' house that I ain't never been in no
13 house.

14 DETECTIVE JELLICO: No, you're missing. Maybe I'm making
15 it confusing. Picture this, this is what they do. They go
16 there. My boy Banks dead, right. They go in there, they swab
17 little things up and everything. Then they come back and they
18 send it to CODIS. CODIS spits it out and says, Gregory was
19 there.

20 GREGORY GREEN: Anything in there, [inaudible] I
21 ain't been inside that fuckin' house. I wasn't there.

22 DETECTIVE JELLICO: So, that would be your statement.

23 GREGORY GREEN: Period.

24 DETECTIVE JELLICO: That would be your statement.
25

1 GREGORY GREEN: I ain't been there period. That's
2 what I'm saying. [crosstalk]

3 DETECTIVE JELLICO: So, if we charge—listen to me now.
4 Gregory, why you get all bugged out?

5 GREGORY GREEN: You're gonna charge me for murder.

6 DETECTIVE JELLICO: No, if they did charge you—if we
7 charge you with murder then, your statement is going to be,
8 when that doctors and all get on the stand and says, yeah, I
9 examined this. This DNA was taken from the house. Yes sir.
10 And, whose DNA was it? Gregory, blah, blah, blah. Is it a
11 chance that it's something else? No. But his statement is,
12 he never was in—is there anyway his DNA could've floated
13 through the air on a butterfly and went into the house? No.
14 Detective, what did he say? I have never been in that house.

15 GREGORY GREEN: Never.

16 DETECTIVE JELLICO: And then you're charged. Then, all
17 of a sudden, when was the DNA collected? At the time of a
18 death investigation. So, at the time of the death
19 investigation they find it, you see what I'm saying?

20 GREGORY GREEN: [crosstalk]

21 DETECTIVE JELLICO: Your DNA shouldn't be there.

22 GREGORY GREEN: You just said, my DNA shouldn't be
23 there.

24 DETECTIVE JELLICO: Right, because you never been in the
25 house.

1 GREGORY GREEN: I ain't never been in the house.

2 DETECTIVE JELLICO: So, there should be no DNA there.

3 GREGORY GREEN: [crosstalk] DNA there?

4 DETECTIVE JELLICO: Because you were there.

5 GREGORY GREEN: No.

6 DETECTIVE: It's real simple man.

7 GREGORY GREEN: Take me to County man. Y'all trying
8 to insult my fuckin' intelligence. I know I ain't been to the
9 house.

10 DETECTIVE: We aren't playing with your
11 intelligence. We're giving you the facts which, he's
12 presented to you—

13 GREGORY GREEN: Facts [inaudible] I wasn't fuckin'
14 there. That's actual factual. I ain't had shit to do with
15 it. But you know what, I fuckin' glad his ass dead. You know
16 why I glad he dead?

17 DETECTIVE: Uh huh.

18 GREGORY GREEN: You know why?

19 DETECTIVE: Why?

20 GREGORY GREEN: Nigga done killed several of my
21 motherfuckin' homeboys. Nigga done shot at me. Them boys
22 tried to kill me.

23 DETECTIVE JELLICO: Not too long before this.

24 GREGORY GREEN: No, that been years before that.

25 DETECTIVE JELLICO: [crosstalk]

1 GREGORY GREEN: Hey, I ain't did shit to nobody. I
2 ain't had nobody do nothing to nobody. [crosstalk] Man,
3 listen, I ain't been there. Three people roll out, five
4 people roll out. I don't know who the fuck roll out. You
5 know why? It's still a good thing. It's still a good thing
6 in my book.

7 DETECTIVE JELLICO: He killed a couple of people.

8 GREGORY GREEN: You know what I'm saying.

9 DETECTIVE JELLICO: I know that.

10 GREGORY GREEN: All right.

11 DETECTIVE JELLICO: I know he wasn't no saint. He wasn't
12 going to Sunday school.

13 GREGORY GREEN: I ain't had shit to do with that
14 situation.

15 DETECTIVE JELLICO: You just wish you had.

16 GREGORY GREEN: Yes. Like, honestly and truthfully,
17 I wish I did. I'd have-psst.

18 DETECTIVE: And there's no way that you were in
19 the car that went to the murder.

20 GREGORY GREEN: Man, I don't know nothing about none
21 of that shit. Please take me to County man. You saying I
22 been in the car.

23 DETECTIVE JELLICO: [crosstalk]

24 DETECTIVE: Huh?

25 GREGORY GREEN: Take me man.

1 DETECTIVE JELLICO: [crosstalk] other thing.

2 GREGORY GREEN: Take me man. Be in the car, I don't
3 know what the fuck y'all talking about man.

4 DETECTIVE JELLICO: Let him get the thing, the papers, I
5 don't know either.

6 DETECTIVE: [leaves room]

7 GREGORY GREEN: Well, I just need to go to County
8 man. I'm done talking because y'all [inaudible]

9 DETECTIVE JELLICO: [inaudible] to hem you up.

10 GREGORY GREEN: I know. I'm being serious. It do
11 what it do. [inaudible] however, I ain't give a fuck, I ain't
12 been there.

13 DETECTIVE JELLICO: What's the longest stint you did up
14 the road?

15 GREGORY GREEN: Listen, this the shit-like, two
16 years. This the shit that I don't understand. First, you
17 trying to say I killed my cousin.

18 DETECTIVE JELLICO: I ain't trying to say that.

19 GREGORY GREEN: I ain't did that. Wouldn't do that.
20 You get what I'm saying.

21 DETECTIVE JELLICO: Right and remember I told you that.

22 GREGORY GREEN: Now, I would kill that motherfucker
23 nigga Banks though. I'll shoot his fuckin' ghost if he comes
24 back.

25 DETECTIVE JELLICO: And that's the problem we have.

1 GREGORY GREEN: I wasn't there. I don't-

2 DETECTIVE JELLICO: [crosstalk]

3 GREGORY GREEN: Huh?

4 DETECTIVE JELLICO: [inaudible]

5 GREGORY GREEN: They got what?

6 DETECTIVE JELLICO: They got you at the scene.

7 GREGORY GREEN: They can't have me at the scene. I
8 live right around there but I ain't been there. And, listen,
9 right-right around the corner now.

10 DETECTIVE JELLICO: I know that.

11 GREGORY GREEN: I passed by all the fuckin' time. I
12 been passing him all the time. Going [inaudible] on Terry
13 Drive at the other end.

14 DETECTIVE JELLICO: You don't ever have work, or he
15 [crosstalk]

16 GREGORY GREEN: We don't even talk to each other.

17 DETECTIVE JELLICO: What was he slanging?

18 GREGORY GREEN: Crack, coke. I guess, I don't know.
19 Same shit. I don't fuck with him though. I don't fuck with
20 him. Walking through-I walk through that field all the time.
21 Shit.

22 DETECTIVE JELLICO: Which one, the field between the
23 houses?

24 GREGORY GREEN: Behind-yeah, because my fuckin'
25 cousin-

1 DETECTIVE JELLICO: [crosstalk]

2 GREGORY GREEN: --Mona, live right there behind,
3 wherever the fuck he was staying at. Her and her fuckin'
4 husband. And my cousin Terry be down there. So, I be walking
5 that way. My homeboy used to live on Terry Drive down the
6 street and I used to walk that way. Motherfuckin' Vin-uncle
7 Vinnie, who I serve the hard to, he live on-where that is,
8 [inaudible] that's the last street.

9 DETECTIVE JELLICO: You got family all up in there.

10 GREGORY GREEN: Yeah. I'm saying, this shit
11 retarded, the whole area man. I ready to go man. I ready to
12 go to sleep.

13 DETECTIVE JELLICO: Sit down. Sit down until he gets
14 back with his little paper.

15 GREGORY GREEN: I need to use the phone. I need to
16 go to sleep.

17 DETECTIVE JELLICO: You done cracked your phone all up.

18 GREGORY GREEN: I cracked the phone because I see the
19 police and I know that's how god damn they came.

20 DETECTIVE JELLICO: Ain't it a little late to crack the
21 phone when they there, you know what I'm saying.

22 GREGORY GREEN: I just need to sleep. I need to go
23 to sleep because y'all really making my fuckin' head hurt.
24 Trying to involve me in a murder. A murder.

25 DETECTIVE JELLICO: Go to sleep?

1 GREGORY GREEN: A murder on top of murder. Now, I
2 just a fuckin' contract killer or some shit. This is fuckin'
3 crazy. I broke, I sellin' rock. To survive, feed my
4 children. Now, everybody fuck up because I locked up for some
5 shit I ain't got nothing to do with.

6 DETECTIVE JELLICO: And all you're doing is slanging
7 dope, that's it.

8 GREGORY GREEN: Slanging dope, dog. [pause]

9 DETECTIVE JELLICO: I hate to see it, you got all them
10 kids man, get hemmed up. Honestly, I do.

11 GREGORY GREEN: That's why I saying, this retarded
12 dog.

13 DETECTIVE JELLICO: Because, I don't want to hem you up,
14 it's bad.

15 GREGORY GREEN: [crosstalk] hem me up.

16 DETECTIVE JELLICO: This right here, seriously, I don't
17 care nothing about Banks. You know why I ain't really worked
18 on that, you know why I'll tell you, because Banks was a piece
19 of crap. That's why I ain't worked on it that hard.

20 GREGORY GREEN: I mean, if I was killing that piece
21 of shit-killing ain't my thing. I ain't got the balls for
22 that shit. That shit gonna weigh on my fuckin' conscious too
23 much.

24 DETECTIVE JELLICO: [inaudible] him, because I would've-
25 listen, when I was doing him, doing the case, everybody was

1 saying what you're saying. It wasn't just you saying like,
2 now, you know what I'm saying. It wasn't like, everybody was,
3 oh he's great. No, uh-uh. What hurts is to clear you from
4 that is going to be hard.

5 GREGORY GREEN: Man, listen, I don't give a fuck how
6 hard it gonna be, I ain't been there, I ain't did shit.

7 DETECTIVE JELLICO: But you see what I mean, I can't-what
8 do I do with the DNA?

9 GREGORY GREEN: Y'all saying, y'all find a fuckin'
10 phone.

11 DETECTIVE JELLICO: That's more than one person there.

12 GREGORY GREEN: [crosstalk]

13 DETECTIVE JELLICO: That's why I didn't think you was the
14 shooter.

15 GREGORY GREEN: DNA come off the phone now who the
16 fuck to say somebody ain't grabbed my fuckin' phone.

17 DETECTIVE JELLICO: DNA don't though.

18 GREGORY GREEN: I ain't been there dog.

19 DETECTIVE JELLICO: DNA-the phone was outside where the
20 car was. By the back door.

21 DETECTIVE: [enters room]

22 GREGORY GREEN: DNA come off the-[crosstalk] I don't
23 know nothing about none of that shit [mumbles, inaudible]

24 DETECTIVE: All right.

25

1 DETECTIVE JELLICO: So, let me ask you this, if your
2 phone was stolen, what was the number of that phone back
3 there?

4 GREGORY GREEN: I don't even fuckin' know man. I
5 really don't know. I change numbers every 30 days and that
6 phone—I had a phone [inaudible] I just had came back from
7 Augusta. I just came back from Augusta, so—and my dumb ass,
8 what I did, I left the bags in the car. The phone that, in
9 question was phone, that my trickin' phone. I had another
10 [inaudible]

11 DETECTIVE JELLICO: Your who?

12 GREGORY GREEN: My trickin' phone. I had another
13 [inaudible] I carry in the house around the wifey.

14 DETECTIVE JELLICO: So, the phone we found, is the one
15 you're saying was stolen out of the van.

16 GREGORY GREEN: It had to been—it had to been the
17 phone that come with the van because that's the only time I
18 ever lost a phone.

19 DETECTIVE JELLICO: Well, why would they keep your phone?

20 GREGORY GREEN: They took the whole bag. They took
21 the clothes. They take my fuckin' god damn phones.

22 DETECTIVE JELLICO: Your?

23 GREGORY GREEN: [inaudible]

24 DETECTIVE JELLICO: Oh, oh, oh.

25

1 GREGORY GREEN: [inaudible] must've leave them shit
2 because I had a bag of clothes and-

3 DETECTIVE JELLICO: Describe that phone.

4 GREGORY GREEN: Which phone? The phone that I got
5 lost? That got lost?

6 DETECTIVE JELLICO: Yeah.

7 GREGORY GREEN: It's a flip phone.

8 DETECTIVE JELLICO: Just a little teeny, like I get-

9 GREGORY GREEN: It's a flip phone because I can't-you
10 know what I'm saying, I just for communication-

11 DETECTIVE JELLICO: Whose numbers would've been in there?
12 [inaudible] the phone.

13 GREGORY GREEN: Whose numbers would've been in there?

14 DETECTIVE JELLICO: Because that may help you [crosstalk].

15 GREGORY GREEN: --bitches.

16 DETECTIVE JELLICO: I mean, give me somebody that I could
17 say, oh this is so and so, oh I look at the phone, he's
18 telling the truth.

19 GREGORY GREEN: Sales and bitches.

20 DETECTIVE JELLICO: I mean-no, no, no. I mean, what's a
21 name that would've been in the phone? That I could say, hey
22 he's telling me the truth. He told me about the phone. His
23 phone was stolen.

24

25

1 GREGORY GREEN: Shit. [pause] I know-[pause] I got
2 to think about that. How long [inaudible] I got to think of a
3 name.

4 DETECTIVE JELLICO: You said, [crosstalk]

5 GREGORY GREEN: I mean, that's the only number I can
6 really think of off the top.

7 DETECTIVE JELLICO: Because that-before we leave, let me
8 clear you on this, all right? Let me get the phone and let's
9 do that. Because you told me before, I told you that the
10 phone was taken. Does that make sense? All right, Pooch?
11 Peel?

12 GREGORY GREEN: Really-

13 DETECTIVE JELLICO: Let me get that real quick.

14 GREGORY GREEN: And, right by-I already know how it
15 broke in the car because the car been parked on the side of
16 the house. And, the lot next to the house, motherfuckers walk
17 through the field.

18 DETECTIVE JELLICO: All right. Let me-I'll be right
19 back. Let me get-because I ain't got nothing right here.
20 [leaves room]

21 DETECTIVE: So, here on the other case, Bailey,
22 I've got three warrants for you there. It states that on June
23 8th at approximately 4:30 in the morning, at [REDACTED] Bailey Street
24 located in the City of North Charleston, County of Charleston,
25

1 State of South Carolina, the Defendant, Gregory Green did
2 commit the offense of murder.

3 On-the Defendant did willfully and unlawfully shoot the
4 victim, Freeman Rivers, which resulted in his death. The fact
5 that established the aforesaid is that on June 8th at
6 approximately 4:46 AM, Officers with North Charleston Police
7 Department responded to a fire at [REDACTED] Bailey Street.
8 Firefighters located a male body identified as Freeman Rivers.
9 Autopsy showed that Rivers had sustained multiple gun shots
10 and resulted in his death.

11 Detectives obtained a description of the vehicle used by
12 the Defendant who was seen entering and fleeing the victim's
13 residence the night of the incident. The vehicle was
14 described as a light blue or silver Chrysler 200. Video from
15 the area, an hour prior to the incident, shows the 2017 light
16 blue Chrysler 200, bearing South Carolina tag, [REDACTED] entering
17 the neighborhood and pulling into the [inaudible] Gas Station
18 at 3615 [inaudible] Road.

19 A witness to be named in court provided a third-party
20 confession indicating that the co-defendant dropped off and
21 picked up the Defendant who committed the murder and advised
22 him to burn the house along with the evidence. The witness
23 stated that, statements were corroborated by details provided
24 by other witnesses that viewed the car drop off and pick up
25 the suspect and gave the initial description.

1 In addition, the witness stated that the vehicle had
2 blood transfer to the interior of the car, as the suspect of
3 the crime was covered in the victim's blood at the time of the
4 incident.

5 On June 22, 2017, the 2017 Chrysler 200 was reported
6 stolen and recovered--was located after being reported stolen
7 on June 19, 2017. Testing of the interior of the vehicle
8 reviewed presumptive positive for trace evidence of blood,
9 after a search was conducted of the car, pursuant to a lawful
10 search warrant.

11 Defendant's cell phone records indicate that he was on
12 Bailey Street during the time of the incident. And matched
13 the witnesses description of the timeline of the events. The
14 witnesses also heard the name "Kone" uttered by the co-
15 defendants when searching for him in the front of the house.
16 This is a known alias of the Defendant.

17 GREGORY GREEN: What the fuck? Man, on my momma,
18 this is some bullshit.

19 DETECTIVE: Well and this is what I'm talking
20 about.

21 GREGORY GREEN: This is bullshit.

22 DETECTIVE: Each one of these has the same facts
23 pretty much--

24 GREGORY GREEN: [inaudible] let me read these shits
25 with you.

1 DETECTIVE: We have arson. Possession of a
2 firearm in the commission of a violent crime.

3 GREGORY GREEN: Violent crime.

4 DETECTIVE: And then murder.

5 GREGORY GREEN: That's bullshit bro.

6 DETECTIVE: Now, here's the thing, it's like I
7 told you, all of that puts you there. Okay? It puts you
8 there conclusively. There's no other way your-your-you got
9 there. Okay? But now, besides all of that, you have a way to
10 explain why you were there.

11 GREGORY GREEN: Man, listen. I ain't had shit to do
12 with that shit and I ain't fuckin' been there man. That's my
13 fuckin' cousin dog. Take me to County man. [crying]

14 DETECTIVE: So this-this--

15 GREGORY GREEN: Take me to County man.

16 DETECTIVE: This is car, do you know the owner of
17 this car?

18 GREGORY GREEN: I don't know who the fuck car that
19 is. I don't-I don't--

20 DETECTIVE: Do you know Bezel?

21 GREGORY GREEN: Bezel?

22 DETECTIVE: Bezel.

23 GREGORY GREEN: I know of a Bezel, yeah I know a
24 Bezel.

25 DETECTIVE: That's Bezel's car.

1 GREGORY GREEN: So what the fuck that got to do with
2 me?

3 DETECTIVE: You hang out with Bezel?

4 GREGORY GREEN: Yeah, we know each other. We
5 associate with each other.

6 DETECTIVE: But do you hang out? Do you ride
7 around with him?

8 GREGORY GREEN: Yeah, I done been in his car before.

9 DETECTIVE: So, you told me you don't know no-no
10 Chrysler 200 but that's--

11 GREGORY GREEN: I just said I don't know—I be in a
12 lot of cars, I never told you I don't know Chrysler 200.

13 DETECTIVE: But you hang out with Bezel.

14 GREGORY GREEN: We party together.

15 DETECTIVE: Were you with him that night?

16 GREGORY GREEN: We throw house parties? At the club.

17 Since you want to say that, at the club, when I sit in his
18 motherfuckin' car, we roll to the [inaudible] parked in front
19 of Bistro, that night right there.

20 DETECTIVE: And so, now his car is seen on video
21 leaving the Bistro going to that area, and it goes to and from
22 that area repeatedly.

23 GREGORY GREEN: Listen. [inaudible] the Bistro,
24 right? I ain't in this fuckin' car. I know, I walk. I walk
25 home dog.

1 DETECTIVE: So, how are you in there? How is
2 your phone showing that you were on Bailey Street that night?

3 GREGORY GREEN: How my phone I been on Bailey Street
4 that night? I want to know how the fuck my phone show I been
5 on Bailey Street that night.

6 DETECTIVE: I just told you, it was.

7 GREGORY GREEN: Uh, uh, no, from my recollection, all
8 that [inaudible] you're already saying, so I been at my
9 fuckin' house. How the fuck my phone get on Bailey Street?

10 DETECTIVE: And, why does some random person hear
11 your name in the street?

12 GREGORY GREEN: Exactly. Why did some random person
13 calling my name, just like I saying my baby mom done this
14 bullshit before with [inaudible]

15 DETECTIVE: No, that night. That night. Someone
16 heard your name, a person that don't even know you from Adam.

17 GREGORY GREEN: How the fuck somebody hear my name?
18 I ain't been there. I ain't been with him. In that car, I
19 been in [inaudible]

20 DETECTIVE: [crosstalk]

21 GREGORY GREEN: I can't see him doing no shit like
22 that. That ain't the type of person he is.

23 DETECTIVE: Because, I mean that's the only other
24 available option is that he did it.

25

1 GREGORY GREEN: I can't see him doing no shit like
2 that and as far as—he don't even know my fuckin' cousin.

3 DETECTIVE: Well, I mean, his car went to the
4 house right there. So, either Bezel did it, or you did it or
5 you were there with Bezel. [pause]

6 GREGORY GREEN: Man, I ain't been there dog. But you
7 saying—I don't see that, oh no, I can't see that shit dog.

8 DETECTIVE: Because that's where it leaves it.

9 GREGORY GREEN: I can't see that.

10 DETECTIVE: That's where it leaves it. It puts
11 Bezel there on scene, killing your cousin.

12 GREGORY GREEN: I don't—I can't see that.

13 DETECTIVE: If you ain't in the car with him and
14 they ain't another third or fourth party in the car with
15 y'all, then what—what do we have left? What is—you said I was
16 insulting your intelligence. I'm leaving it to your
17 intelligence to tell me, what does that leave?

18 GREGORY GREEN: Yeah, that's like--

19 DETECTIVE: You see that this leaves it as only
20 one answer.

21 GREGORY GREEN: That's crazy man.

22 DETECTIVE: Do you see that?

23 DETECTIVE JELLICO: [enters room]
24
25

1 DETECTIVE: So, if this leaves it at one answer
2 and the answer you're giving me don't make sense because it
3 don't match the evidence. It just ain't gonna jive.

4 GREGORY GREEN: I live right there across the street
5 from him dog, so how the fuck-you walk-the flowers shop, the
6 corner store, my house.

7 DETECTIVE: Uh huh.

8 GREGORY GREEN: You get what I'm saying?

9 DETECTIVE: I know exactly what you're talking
10 about. I've driven the area, walked the area. I know exactly
11 where you're talking about. You're the first house on the
12 right. Big, yellow house.

13 GREGORY GREEN: Yeah.

14 DETECTIVE: Right past-I know where you live.
15 That ain't the question.

16 GREGORY GREEN: That's like, crazy man. That's
17 retarded.

18 DETECTIVE JELLICO: Let me show you this. This is a-

19 GREGORY GREEN: The only time I ever-I don't even
20 think I go into [inaudible]. Matter of fact, did I go to the
21 house that night, or did I go by my sister's house? That's
22 the only way that shit could be-matter-yeah. The only way-
23 that's when I served my sister's boyfriend the coke on
24 Cambridge.

25 DETECTIVE: So, you went to Cambridge.

1 GREGORY GREEN: That's the only way.

2 DETECTIVE: What time did you go to Cambridge?

3 About how long after the Bistro?

4 GREGORY GREEN: [pause] That been damn near right
5 after the Bistro because after that, I go on home.

6 DETECTIVE: Bezel give you a ride?

7 GREGORY GREEN: No. Bezel didn't give me no ride. I
8 walk. And she call and I go on, walk.

9 DETECTIVE: You walked from your house.

10 GREGORY GREEN: To Cambridge.

11 DETECTIVE: To Cambridge.

12 GREGORY GREEN: Word. Bezel ain't-matter-no, that's
13 crazy.

14 DETECTIVE JELLICO: Let me show you this.

15 DETECTIVE: Because you know I locked up Bezel on
16 this, right?

17 DETECTIVE JELLICO: This your phone?

18 GREGORY GREEN: Uh huh.

19 DETECTIVE JELLICO: You know [inaudible] names. Do you
20 remember these people?

21 GREGORY GREEN: [pause] Yeah, that's-that's my
22 trickin' phone.

23 DETECTIVE JELLICO: Look at the names in here.

24

25

1 GREGORY GREEN: This--this been a trickin' phone, it
2 was, that's a trickin' phone. Amanda, this my trickin' phone.
3 That's why I can't take the phone in the fuckin' house, dog.

4 [crosstalk]

5 GREGORY GREEN: That's why I can't take the phone. I
6 hide the shit up under the step. If I had been in the car,
7 I'd have had--[crosstalk]

8 DETECTIVE JELLICO: This is your phone. Look at it and
9 make sure now, all these people on here. I see Pooch and all
10 that. And, Foot #2, who the hell is Foot #2? Foot dead.

11 GREGORY GREEN: All right. And that been Foot
12 number. The second number, I never erased that shit. That's
13 the fuckin' same phone but I ain't been there during these
14 fuckin' crimes.

15 [crosstalk]

16 DETECTIVE JELLICO: Shit. You know these people? That's
17 your phone, these are your contacts?

18 GREGORY GREEN: [crosstalk] my phone, the phone get
19 stolen out my fuckin' car. [crosstalk]

20 DETECTIVE JELLICO: That's what I'm saying, this is the
21 ~~one~~ you got stole out your car.

22 GREGORY GREEN: That's the phone that come up missing
23 out my car. The fuckin' flip phone. When I came back from
24 fuckin' Atlanta--Augusta. I keep saying Atlanta.

25

1 DETECTIVE JELLICO: You recognize all this then. This is
2 your people.

3 GREGORY GREEN: That's stupid man.

4 DETECTIVE JELLICO: Now, what about this other boy-

5 GREGORY GREEN: And?

6 DETECTIVE JELLICO: Uh huh.

7 GREGORY GREEN: My-[pause] Well, the steal the bag
8 of clothes. [inaudible] I served them little niggas from off
9 of that night. What I did, I went by, served them little boys
10 and then, [inaudible]. Yeah, [inaudible] Served the little
11 boys.

12 DETECTIVE JELLICO: This one here, right?

13 GREGORY GREEN: I served the little boys.

14 [inaudible] my phone get stolen, so that was making me think
15 one of them had take my fuckin' phone. Word, because I served
16 like three or four of them little niggas. Served that, did
17 that and came back to the house.

18 DETECTIVE JELLICO: Now, on this fella here.

19 GREGORY GREEN: That shit there retarded. Y'all

20 [crosstalk]

21 DETECTIVE JELLICO: This dude come in here, you know they
22 picked him up, right?

23 GREGORY GREEN: Yep.

24

25

1 DETECTIVE JELLICO: And he says, right. He says, that he
2 picked you up. So, he's putting himself in trouble. You
3 learned this—did you see him on the news?

4 GREGORY GREEN: No.

5 DETECTIVE JELLICO: You didn't see him on the news?

6 GREGORY GREEN: I ain't trying to be on the news for
7 killing my fuckin' cousin.

8 DETECTIVE JELLICO: No, no, I didn't say that. Did you
9 see him on the news.

10 GREGORY GREEN: Man, I ain't trying to be locked up
11 for killing my cousin.

12 DETECTIVE JELLICO: I didn't say that.

13 GREGORY GREEN: I ain't see him on the news. I ain't
14 see none of that.

15 DETECTIVE JELLICO: You didn't hear about it on the
16 street that he got picked up.

17 GREGORY GREEN: I heard about him getting locked up
18 but what the fuck does that have to do with me?

19 DETECTIVE JELLICO: That's what I'm saying, you didn't
20 know he got picked up. You didn't know what he got picked up
21 for?

22 GREGORY GREEN: Them boys say he get picked up for
23 accessory to murder, before the fact. Okay. What the fuck
24 does that have to do with me.

25

1 DETECTIVE JELLICO: Because he come in here and says, it
2 was you.

3 GREGORY GREEN: Man, ain't no way in hell.

4 DETECTIVE JELLICO: That's what—they wouldn't get this in
5 front of a Judge boo. Come on Gregory, you ain't stupid.

6 GREGORY GREEN: Man. Take me to County bro. Ain't
7 no way in hell this motherfucker say he been with no fuckin'
8 me dog.

9 DETECTIVE JELLICO: So, they would just lie?

10 GREGORY GREEN: Dog, he ain't been with no me. I
11 ain't been with no fuckin' him. Come on man, take me to
12 County man. That's bullshit. Motherfuckers do dumb shit.
13 That's dumb nigga shit.

14 DETECTIVE JELLICO: Why would he do that? You see what
15 I'm getting at?

16 DETECTIVE: It's like I told you a minute ago.
17 Either he did it, you did it or you were both there and
18 there's some other circumstance that you're not telling us
19 about.

20 GREGORY GREEN: Man, listen, I ain't been there. I
21 ain't did that shit. [inaudible] time, matter of fact, when I
22 walking from the fuckin' club. That's what the fuck I did.
23 Go and serve my sister's boyfriend and came home. Why—I ain't
24 even walk down Bailey. I go straight down Ackerby [phonetic]

25

1 Road and take the cut because I ain't want Angelo to see me
2 because I ain't had no fuckin' weed for him.

3 DETECTIVE JELLICO: So he called you before.

4 GREGORY GREEN: Yeah, he called me like 11:00
5 something, before. And that's why I been going that way.
6 Now, whoever the fuck, little dog running with or whatever he
7 do in his spare time, that's-[crosstalk] No, no, he probably
8 do know Angelo. You know how he probably do know Angelo,
9 because that's the neck of the woods where he'll be throwing
10 the house parties and shit. He'll be out there on
11 [inaudible]. I ain't got shit to do with that shit dog.
12 [inaudible] I know for a fact, Bezel be on [inaudible] because
13 that's one of the house boys spot.

14 DETECTIVE JELLICO: Help me out on this. Just one
15 question. Why would he come up here and say you?

16 GREGORY GREEN: I don't know why the fuck he would
17 come up here and say me.

18 DETECTIVE JELLICO: Because if he had never said you,
19 guess what? You wouldn't be sitting here.

20 GREGORY GREEN: I ain't-

21 DETECTIVE JELLICO: Because he got a lot to lose, right
22 and he's saying he was there. So, he's admitting that he was
23 there. And then he's saying, I was there but-

24 GREGORY GREEN: [crosstalk] water because this a
25 bunch of bullshit.

1 DETECTIVE JELLICO: Okay, I'll get you some water. But
2 you see why it's important we talk about this?

3 GREGORY GREEN: [crosstalk] Yeah.

4 DETECTIVE JELLICO: If we put you in jail, like this,
5 with no excuse, then you're going to get hemmed up because
6 this boy is saying, look, I was there—I was there, but also my
7 boy Gregory was there with me. And, this is what happened.

8 GREGORY GREEN: Man, listen, he can do whatever the
9 fuck he want to do.

10 DETECTIVE JELLICO: And, blood in the car and everything.

11 GREGORY GREEN: [crosstalk]

12 DETECTIVE JELLICO: Man, you want a water, right?

13 GREGORY GREEN: Yeah.

14 DETECTIVE JELLICO: [leaves room]

15 DETECTIVE: It goes beyond just the—the
16 culpability of Terrence. It's the fact that there's other
17 people that see you leave the house, go back into his car.
18 Neighbors that physically saw what happened. That night.

19 GREGORY GREEN: I don't.

20 DETECTIVE JELLICO: [enters room]

21 DETECTIVE: People that witnessed every single
22 bit of it.

23 GREGORY GREEN: Man, listen. You can tell me
24 anything you want to tell me, right, right now. And I ain't
25 believing that shit because I know I ain't fuckin' been there.

1 I ain't did nothing to my fuckin' cousin. That other nigga?
2 I wish I would've been able to do something to him, but I
3 ain't did nothing to my fuckin' cousin dog. That's bullshit.

4 DETECTIVE: I mean, that's a sad way he died.

5 GREGORY GREEN: That's a real fuckin' sad, sorry ass
6 way to kill a motherfucker who already dying, dog.

7 DETECTIVE: I mean, that was brutal. There's no
8 reason that he should've died that way.

9 GREGORY GREEN: Ain't no reason for nobody to die.

10 DETECTIVE JELLICO: Well, some of them need to go.

11 GREGORY GREEN: Yeah, like Banks.

12 DETECTIVE JELLICO: Some of them—well, more than that.
13 More of them need to go.

14 GREGORY GREEN: Man, my nigga—that's not even my
15 character, statute [sic] none of this shit. None of this
16 shit.

17 DETECTIVE JELLICO: We're—you've got to understand, we're
18 not here just to convict you.

19 GREGORY GREEN: [inaudible] convict me. You can't—

20 DETECTIVE JELLICO: We're trying to clear you. How the
21 hell are we supposed to clear you?

22 GREGORY GREEN: I was not there.

23 DETECTIVE JELLICO: But you want us to just put you in
24 jail and two and a half years from now, they try you. And
25 they say, hey, this dude gets on the stand and says, blah,

1 blah, blah. They get evidence, whatever they get and then
2 you're sitting there like, I wasn't there.

3 GREGORY GREEN: I wasn't fuckin' there.

4 DETECTIVE JELLICO: And then you go to prison for the
5 rest of your life.

6 GREGORY GREEN: Man, that's gonna be something I have
7 to fuckin' do because I ain't-

8 DETECTIVE: You're going to have to explain how
9 some of this stuff ended up being the way it is because the
10 fact of the matter is, that information is true. Coupled with
11 the rest of the information that I've told you about, the DNA
12 in the car, everything-you're going to have to explain how all
13 of that is [crosstalk]

14 GREGORY GREEN: DNA in the fuckin' car? DNA in the
15 car, what the fuck that DNA in the car got to do with me? My
16 DNA?

17 DETECTIVE: That puts you in the car the night
18 of.

19 GREGORY GREEN: I tell you I was sitting in the
20 motherfuckin' car by the club. [crosstalk]

21 DETECTIVE: But I asked you-

22 GREGORY GREEN: And, the owner of the club was
23 sitting right there when I was doing it. [inaudible] Bezel
24 car was parked right there where you usually park at, on the
25 corner of [inaudible] and Reynolds, behind the gate. I rode a

1 cabbie. I been talking to the girl, Neesha. [inaudible] had
2 their little meeting and shit. I don't fuck with the club no
3 more so I walk home.

4 DETECTIVE: So then how do unrelated people that
5 don't even know you identify you coming out the house?

6 GREGORY GREEN: How the fuck-ain't nobody can
7 identify me coming out nowhere because I ain't been there,
8 dog.

9 DETECTIVE: But I'm asking you, how is that
10 possible? Is there any way you could-

11 GREGORY GREEN: Could you please tell me how that's
12 possible if I ain't been there.

13 DETECTIVE: It's not. See, that's the problem.
14 Is that it's not possible. So, it either leaves-it either
15 leaves one option, is that you were there and you're lying
16 about it. Or the other option is that-

17 GREGORY GREEN: Now-now, okay.

18 DETECTIVE: It's-it's just impossible.

19 GREGORY GREEN: [inaudible] try to clear my name on
20 some bullshit, I could've said, yeah, I been there. Yeah,
21 this that and the third. I ain't fuckin' been there.

22 DETECTIVE JELLICO: [enters room]

23 DETECTIVE: So, you're just going to let all the-
24 the mountain of evidence be as it is. You can't even just
25 say, I was there [crosstalk]

1 GREGORY GREEN: Man--

2 DETECTIVE: --and shit went down.

3 GREGORY GREEN: I was not there that night dog. That

4 night right there, the only fuckin' place close to that I been

5 to is Cambridge because that's where my sister house. I go

6 around there and get high at night. And, you say going in his

7 house? The last time I been to his house, I ain't been in

8 there because of the nasty shit dog. The man only owe me \$50,

9 \$60. Every fuckin' month on the first of the month.

10 DETECTIVE: Uh huh.

11 GREGORY GREEN: Why the fuck would I kill my cousin

12 dog?

13 DETECTIVE: I don't know.

14 GREGORY GREEN: Plenty of other motherfuckers out

15 here. He ain't never did shit to me in my life. He never did

16 nothing fucked up with me. He's the one motherfuckin' god

17 damn showed me the first—I built my first Lego set with him.

18 You get what I'm saying.

19 DETECTIVE: Uh huh.

20 GREGORY GREEN: Come on man, take me to County man.

21 DETECTIVE JELLICO: I got a couple of questions I want

22 to—

23 GREGORY GREEN: Please take me to County.

24

25

1 DETECTIVE JELLICO: You need to answer this because this
2 will help you. This ain't got nothing to do with Bailey.
3 This your phone. Right, it was stolen, right.

4 GREGORY GREEN: Man.

5 DETECTIVE JELLICO: How many days prior was it stolen?

6 GREGORY GREEN: They break into my—that been—either
7 the night before or two days before—

8 DETECTIVE JELLICO: [crosstalk] Banks.

9 GREGORY GREEN: Yeah. They have—whatever the fuck had
10 my phone, been casing my fuckin' sales because when I call my
11 god damn sale, it's like, yo, somebody been trying—pull up,
12 you know what I'm saying? And they been casing my fuckin'
13 sales. So—[pause] I got another phone, I transferred all—
14 damn near all my sales to the other phone. And, that's where
15 the fuck it went. That's what make me think that one of them
16 little dudes who I served because one of the junkies who I had
17 served said, them boys telling—they pullin' up, they been
18 acting like they been me on the phone but it wasn't me when
19 they pull up. Word. That shit retard. I just get back from
20 Augusta.

21 DETECTIVE JELLICO: Before—before this got stolen.

22 GREGORY GREEN: I just had come back from Augusta
23 before the phone get stolen. The phone gets stolen—

24 DETECTIVE JELLICO: You served a couple of fellas and—
25

1 GREGORY GREEN: Served a couple of people on
2 Montague. Well—yeah, on Montague. [pause] Going in the
3 fuckin' house, had sex with my wife. Woke up. And the
4 fuckin'—see, my passenger door on the van didn't lock. The
5 door wide open. You get what I saying.

6 DETECTIVE JELLICO: Uh huh.

7 GREGORY GREEN: So, everything gone out the car. My
8 True Religion jeans. My phone [inaudible]. My trickin'
9 phone. Everything gone and a little bit of molly that I had
10 left because I served them boys like four grams. Y'all can
11 take me to the County now. I'm sleepy. I'm frustrated
12 because this shit don't make no sense to me. I got to call my
13 sister and tell my sister, man, they got me locked for killin'
14 my fuckin' cousin. This a bunch of bullshit bro, on my life.
15 No.

16 DETECTIVE JELLICO: The Banks thing is not going to go
17 away.

18 GREGORY GREEN: I ain't care about the Banks
19 situation.

20 DETECTIVE JELLICO: Yeah, but it's not going to go away
21 because your DNA is in the house. Which shows you were there.
22 Your phone is outside, in—where they went.

23 GREGORY GREEN: My DNA—

24 DETECTIVE JELLICO: Yeah. And that right there is going
25 [inaudible] right there.

1 GREGORY GREEN: Charge me with that shit too man.

2 This shit dumb man. You said the Feds got that?

3 DETECTIVE JELLICO: No, no, no, we got that. Ain't no
4 Feds.

5 GREGORY GREEN: that's crazy.

6 DETECTIVE JELLICO: Feds is just helping. They ain't got
7 nothing to do with this.

8 GREGORY GREEN: I'm saying, that's fuckin' crazy man.

9 DETECTIVE JELLICO: And you will go down—let me ask you
10 this. Just think about this, you're going to go down for all
11 this by yourself.

12 GREGORY GREEN: Man, my nigga, I ain't trying to go
13 down for shit.

14 DETECTIVE JELLICO: But you will.

15 GREGORY GREEN: If I known something, I'd tell you.
16 I ain't been there man.

17 DETECTIVE JELLICO: At Banks, you were there. I know
18 that. The phone, the DNA, you were in the house when it went
19 to crap.

20 GREGORY GREEN: That phone—

21 DETECTIVE JELLICO: It don't matter. The phone was being
22 used right up to the time when the thing happened.

23 GREGORY GREEN: That means somebody was [inaudible]

24 DETECTIVE JELLICO: And it was calling people that was
25 related to you. And actually calling people—

1 GREGORY GREEN: [crosstalk]

2 DETECTIVE JELLICO: Yeah, people in your niche that you
3 probably don't serve to. So, I ain't going to tell you
4 everything but you told me enough to put you there 100%.

5 GREGORY GREEN: I ain't been in nobody fuckin' house.
6 My phone got stolen-

7 DETECTIVE JELLICO: Well, maybe you stayed in the car.

8 GREGORY GREEN: I ain't been in no fuckin'-what car?

9 DETECTIVE JELLICO: Maybe [crosstalk]

10 GREGORY GREEN: My fuckin' van that I-[crosstalk] put
11 on the shit, because the manifolds was in the back of the car.
12 My fuckin' van-that shit-I been thinking [inaudible] drinking
13 in the car. And steal the clothes, because the shit been
14 parked in the cut.

15 DETECTIVE JELLICO: That ain't gonna fly. That ain't
16 gonna fly.

17 DETECTIVE: [crosstalk]

18 GREGORY GREEN: I mean, I ain't been there dog.

19 DETECTIVE JELLICO: That-that-let's get past that because
20 I got you there. That's-this is factual evidence that I got
21 you at the-[inaudible] what I didn't understand, I know you
22 didn't like Banks, but you were one of a million that don't
23 like Banks.

24 GREGORY GREEN: That's crazy bro. [inaudible] Terry
25 Street.

1 DETECTIVE JELLICO: You and them other boys went over
2 there and you scared-

3 GREGORY GREEN: Other boys?

4 DETECTIVE JELLICO: This ain't Let's Make A Deal, you
5 know that.

6 GREGORY GREEN: Man, take me to County man because I
7 ain't been there dog.

8 DETECTIVE JELLICO: So, I should just charge you with
9 this.

10 GREGORY GREEN: That's crazy man. I ain't been there
11 dog. You can try to make me--

12 DETECTIVE JELLICO: And, no, no, no, I want to know--
13 [crosstalk]

14 DETECTIVE JELLICO: You were there.

15 GREGORY GREEN: No, I wasn't man.

16 DETECTIVE JELLICO: You were at Terry.

17 GREGORY GREEN: No, I wasn't man.

18 DETECTIVE JELLICO: [crosstalk]

19 GREGORY GREEN: No, I fuckin' wasn't.

20 DETECTIVE JELLICO: Nobody stole your DNA, nobody stole
21 your phone. Nobody left it at the crime scene.

22 GREGORY GREEN: [crosstalk] my DNA, my DNA is my DNA.
23 I ain't [crosstalk]

24 DETECTIVE JELLICO: I think he was gonna whip y'all's
25 ass.

1 GREGORY GREEN: Man, listen, you can't do shit to me
2 because I don't fuck with--

3 DETECTIVE JELLICO: Banks was gonna whip your ass.

4 GREGORY GREEN: He was probably gonna try to do
5 something [inaudible].

6 DETECTIVE JELLICO: That's exactly what he was gonna do
7 and maybe it was as self-defense [crosstalk]

8 GREGORY GREEN: Take me to the County man, because
9 really y'all fuckin'--

10 DETECTIVE JELLICO: I ain't messing with you man. I'm
11 trying to--

12 GREGORY GREEN: Yes you are because you're telling me
13 I [inaudible] I ain't fuckin' been there.

14 DETECTIVE JELLICO: You were there.

15 GREGORY GREEN: I ain't fuckin' been there dog.

16 DETECTIVE JELLICO: But-but the truth is, you don't
17 listen to what I'm saying.

18 GREGORY GREEN: I ain't been there.

19 DETECTIVE JELLICO: How would your stuff get inside that
20 place?

21 GREGORY GREEN: I ain't been there.

22 DETECTIVE JELLICO: You can't make that up.

23 GREGORY GREEN: Exactly.

24 DETECTIVE JELLICO: So, that means it's fact.

25 GREGORY GREEN: No.

1 DETECTIVE JELLICO: There's no way to take DNA and put it
2 in a place. There's no way. There's no way to take
3 somebody's fingerprint and put it in a place. There's no way
4 to do any of that. We can do a lot of stuff but ain't no damn
5 way I can make your DNA appear somewhere.

6 GREGORY GREEN: That's bullshit. Man, I know my DNA
7 ain't there, so that's the shit--

8 DETECTIVE JELLICO: Well, I showed you where it was. I
9 showed you your name on the thing and I was going to try to
10 help you with this because I don't care much about Banks to
11 begin with.

12 GREGORY GREEN: I ain't been there dog. I was not
13 there. I do not know what the fuck is going on.

14 DETECTIVE JELLICO: Now you're making it--now, you're
15 making it Gregory like you went there to kill him. Wow. I
16 didn't think that of you man because I don't think you that
17 kind of dude. If I never thought you was that kind of dude, I
18 wouldn't be wasting my doggone with you.

19 GREGORY GREEN: All right man.

20 DETECTIVE JELLICO: I looked at your record. You ain't
21 got pretty much anything but your little dope stuff.

22 GREGORY GREEN: That's all the fuck I do.

23 DETECTIVE JELLICO: Right. That's why I never thought
24 that you were the trigger man. I knew you was there because I
25 could prove you was there.

1 GREGORY GREEN: Man, take me to fuckin' County man.

2 DETECTIVE JELLICO: We ain't finished yet.

17 Lord, please God, this bullshit. [pause] This shit is
18 [inaudible] [pause] Murder, murder, murder, murder, they
19 trying to charge me with two fuckin' murders. I ain't
20 murdered the first motherfuckin' person. [pause] That's
21 fuckin' crazy dog. Punk ass motherfuckin' bullshit. [pause]
22 My DNA in that car. What the fuck, you trippin', I just was
23 sitting in that muthafucka earlier.

24 DETECTIVE: [opens door]
