
HONORABLE J.A. KITCHINGS,

SINCE WE THE INMATES HERE AT PERRY CORRECTIONAL INSTITUTION DO HAVE PROBLEMS WITH THE MAIL ROOMS WITHHOLDING OR STOPPING OUR LEGAL MAIL, ESPECIALLY WHEN THAT LEGAL MAIL IS A LEGAL ACTION ADDRESSES PRISON OFFICIAL VIOLATIONS WHICH ARISES TO THE LEVEL OF A FUNDAMENTAL DEFECT WHICH INHERENTLY RESULTS IN A COMPLETE MISARRIAGE OF JUSTICE OR IS INCONSISTENT WITH THE RUDIMENTARY DEMANDS OF FAIR PROCEDURE.
