3) he told My friend girl that if she brought him some more money that he will get it push back untill I handle My fed charge and she took him the money and he didnt.

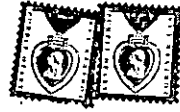
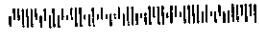
