**PETITION FOR EXTENSION TO FILE

2. Counsel for Robert Darrell Shores respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the


number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the Johnson petition and accompanying appendix in the case of Bennie Lee Griffin v. State with the Supreme Court on August 12, 2020. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Thomas Stewart v. State with the Supreme Court on August 12, 2020. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. James Ficklin with the Court of Appeals on July 27, 2020. Counsel filed the initial brief of appellant and designation of matter in the case of State v. William Brunson with the Court of Appeals on July 27, 2020. Counsel filed the petition for writ of certiorari pursuant to Austin v. State in the case of John Bridges v. State with the Supreme Court on July 27, 2020. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of John Bridges v. State with the Supreme Court on July 27, 2020.






