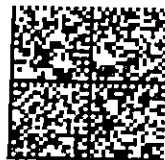

Inmate Sharod Frazier, SCDC #324410, was advised of the identity of the interviewing investigator and the nature of the interview. Frazier provided the following information in the form of a signed statement:

"I, Sharod Frazier, was assigned to Monticello Unit, room 120. I did not give Anthony Sanders, or any other inmate, a knife on May 26, 2013, in Monticello Unit. Sanders, and James Wilson, and Anthony Riggins did come to my cell and asked me for a piece of sheet, to tie to a knife. I did not see the knife. I did not contribute in any way to the assault on inmate Henry Bradley. I heard from inmates June Harris, Malcomb Medlock, and Henry Hickman, that Bradley and Sanders were fighting each other over a homosexual inmate who they called "Stix." Stix was the one who was on lockup until he went home."

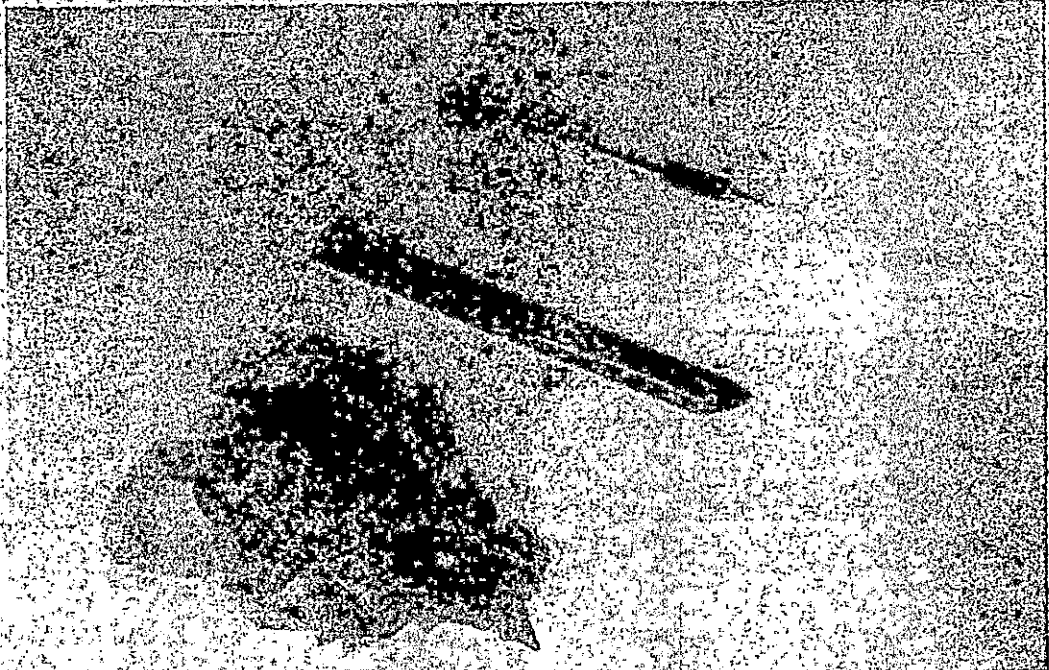

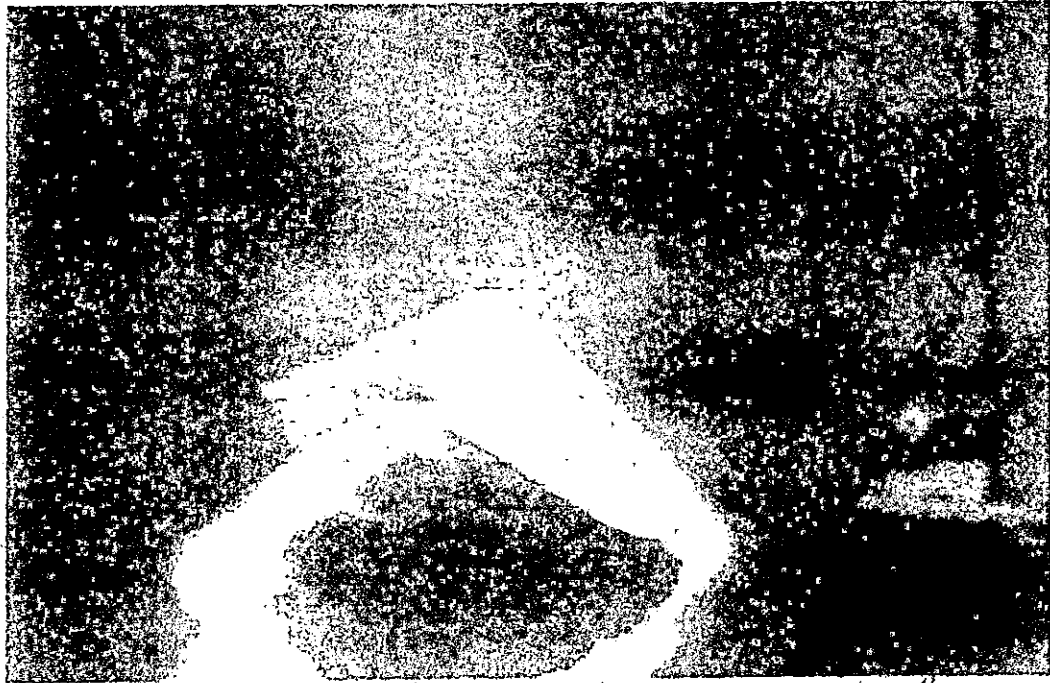

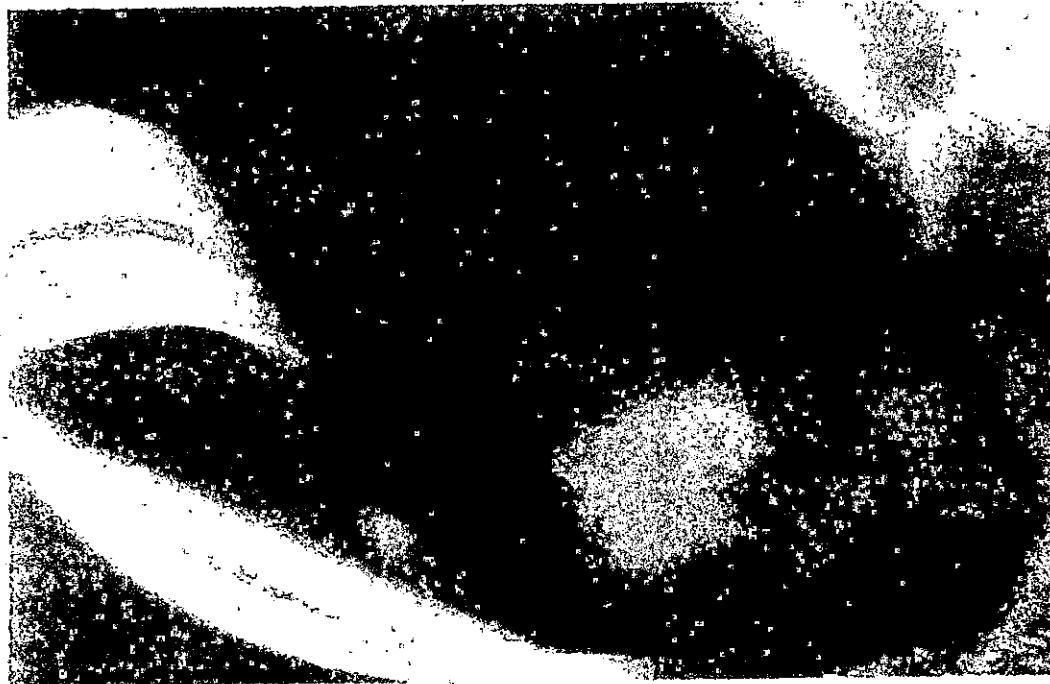

On May 26, 2013, at approximately 9:30PM, the Broad River Correctional Institution (BRCI) Control Room provided the following information to Investigator Estes:

Inmate Henry Bradley, SCDC #141371, had been stabbed in Monticello Unit. Bradley was being transported to the Palmetto Health Richland Hospital (PHRH) for treatment. The crime scene in Monticello Unit had been cleaned by unknown inmates before the First Responders arrived. Investigator Estes responded to PHRH.

At the PHRH, a stab wound was observed on Bradley's left shoulder blade. Another stab wound was observed on Bradley's left side lower back. There were several scratches on Bradley's back. A small, minor abrasion was observed on Bradley's chin. Photographs were taken.

During an initial interview with Bradley at PHRH, Bradley stated that inmate Anthony Sanders, SCDC #273311, aka "Montana," had stabbed him with a homemade knife. Bradley stated that inmates James Wilson, SCDC #155975, and Anthony Riggins, SCDC #178886, held him down at the top of the stairs in Monticello so that Sanders could stab him. Inmate Sharod Frazier, SCDC #324410, had given Sanders the homemade knife. This information was provided to BRCI Major Gregory Washington at BRCI. The inmates were placed on lock-up. Their rooms in Monticello Unit were deadlocked and secured for the investigation.

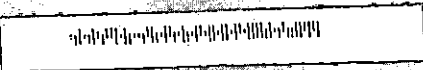

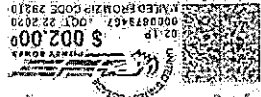
