Dear Mr. Shearouse:

As you are aware, on October 16, 2020, the Court issued its order holding the above-referenced appeal in abeyance pending approval by the circuit court of the parties' September 4, 2020, settlement agreement in principle ("SIP"). The parties are pleased to inform the Court that an order approving the SIP was issued by the circuit court on October 20, 2020 ("Circuit Court Order"). Accordingly, Respondent City of Myrtle Beach respectfully submits that the above-referenced appeal should now be dismissed. I am authorized to represent to the Court that Appellant Horry County consents to a dismissal.

However, and as you are further aware, the City of Myrtle Beach has now filed (a) in the Court of Appeals an appeal from the Circuit Court Order¹ and (b) in this Court a motion to certify that appeal, both as expressly provided for in the SIP. This subsequent appeal only involves resolution of a discrete legal issue regarding disposition of portions of an agreed common fund under Rule 23(e), SCRCF, and has no impact on the matters pending in Appellate Case No. 2019-001134, which involved review of a preliminary issued by the circuit court which is now moot as a result of the SIP. My purpose in mentioning this new appeal is to avoid any question with respect to the ripeness of this request that the appeal in Appellate Case No. 2019-001134 be dismissed.
