Mutterer never presents confirmation of shipment summons,( no signed proof of delivery) and right now no confirmation of the delivery current correspondence regarding Appellate Case No. 2019-001420. 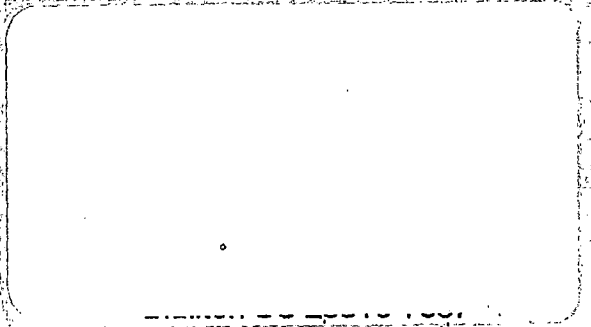


