Hi, Stormy,

We have not received a record on appeal from Mr. Drzazgowski, although the deadline the Court gave him to file the Record and a motion to file out of time passed 12 days ago. Normally, I would ask the opposing counsel or party whether they have mailed the document, but Mr. Drzazgowski has stated that he does not wish to communicate with me. We have found, on the lower court website, a set of documents from the Appellant filed October 23. The first of these documents requests to file out of time (the Court's letter of 10-12-2014 gave him ten days to file such a motion). However, the gist of the Court's letter of 10-12-20 was that Mr. Drzazgowksi was to file a Record on Appeal. The first document that he filed with the lower court on October 23 is addressed to the Honorable V. Claire Allen, and it states his unwillingness to file a Record on Appeal.
