Thank you for your letter of October 21, 2020, reminding me that the transcript is overdue. I checked with our court reporter and she informs me she never received the compact disc of the testimony. (The parties tried this case to a Special Referee based on a video recording of the three municipal meetings that are the subject of this action. Because the Referee reviewed the testimony from the recordings, there was no transcript before the Special Referee.
