MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for Mr. Donald Marquice Anderson respectfully requests a **final extension of thirty (30) days until April 19, 2013**, in which to file the initial brief of appellant and designation of matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fifth request for an extension. In support of this request, counsel shows:

4. Counsel makes this request in good faith and not for purpose of delay.


5. As indicated by signature below, Karen Ratigan, of the South Carolina Attorney General's Office, does not oppose this request.


