
THE APPELLANT'S MOTION TO PROCEED WITHOUT



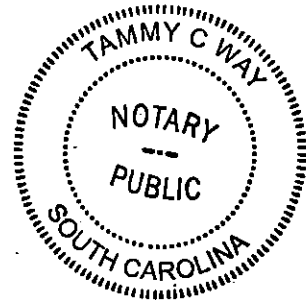

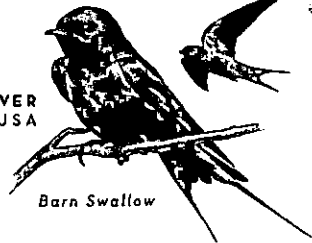
