release or leave with Stellen Warner Bros or Debbie Warner Bros

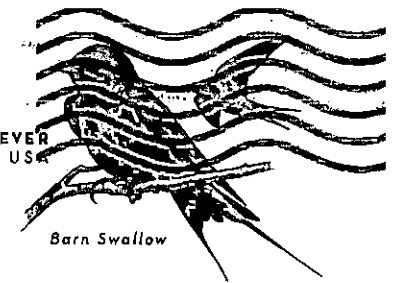
