Please note that I (SC Bar No. 72100) will also be appearing in this matter along with Justin O'Tcole Lucey, Joshua F. Evans, and Edward D. Buckley, Jr. (whose appearances in this appeal are already of record) on behalf of Respondents John Zohlen, Mary Zohlen, Leslie Anne O'Neal, and Trivette C. Hatcher ("Respondents"). I would ask that the Court note my appearance of record. If this request requires a more formal filing, please let me know.

Also, based on the respective dates of service of the initial briefs of the Primary Appellants (brief served January 31, 2013) and Secondary Appellants (brief served January 30, 2013), my understanding is that, pursuant to Rule 208(a)(2), SCACR, the deadlines for the Respondents' initial briefs are March 4, 2013 as to the Primary Appellants and March 1, 2013 as to the Secondary Appellants.


In light of work-related and other time commitments, I ask that the Court grant the Respondents an extension of 30-days' time to file/serve their initial briefs (and corresponding designations of matter) in response to the initial briefs of the Primary and Secondary Appellants. By copy of this correspondence, I am advising all counsel of record of the requested extensions of time.

By my calculations, with the requested 30-days extensions, the Respondents' initial brief in response to the Primary Appellants will be due on or before April 1, 2013, and the Respondents' initial brief in response to the Secondary Appellants will be due on or before April 3, 2013. In any event, I ask that the Court hold the Respondents' briefing deadline in abeyance until it acts upon these requests.
