On 10-12-2020 I was removed from Unit 10 cell 109 after testing positive for Covid-19 to Unit 13 cell 272 which is on lockup for quarantine. I received Judge Letitia H. Verdin order denying my Motion while I was still in Unit 10 - cell 109. I knew from the lab I received that order from the mailroom clerk who brought all legal mail and personal mail to each unit, because there is no movement on the yard. Each unit was on quarantine also. Due to my indigency I put it on the Kiosk on request to 3 legal envelopes to send out my Notice of Appeal and two copies of Judge Letitia H. Robert Watkins 243803. ~~From~~ When I got on lockup on 10-12-2020 obtaining legal material such as legal envelopes where different. I had to send a subpoena 19-11 s.c.r. Request to Sheriff A. Lember for Mr. Robertson. Then I request a notary, in ~~the~~ and copies. When the mailroom clerk come to see me on lockup it was Oct 14 2020. I needed copies and a notary. He told me I had to contact Mr. Butler. I also put that in the Kiosk, but never received a response. I had my tablet

on lookup with me. So I could check the Kiosk reference
to my request for stamp for Notary. The mail room clerk
told me, he would make me copies, and notarized my paper
work. Notice of Appeals and Proof of Service. He took everything
all 3 envelopes to send them off. one to Solicitor Office, Greenville County
one to clerk of Court office of General Sessions Court
Greenville County and one to SC Court of Appeals, he said he
would back date stamp. then with Oct 14, 2020. He was
to send everything off. I haven't heard anything from
The office of the clerk at Court of Greenville County, or the
Office of the clerk of Court concerning my Notice
of Appeal. being ~~not~~ received and filed.

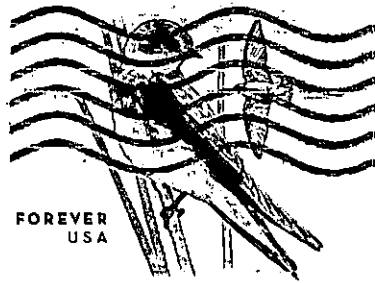
