This responds to your letter dated November 5, 2020.

This office has obtained the enclosed notice of appeal regarding 2016GS2605081, 2016GS2604947, and 2016GS2604953 from the clerk of court for Horry County. This notice of appeal has been filed under Appellate Case Number 2020-001497. Enclosed is an order transferring this appeal to the South Carolina Court of Appeals.

Your document entitled "petition for a writ of certiorari" has been filed under Appellate Case Number Appellate Case No. 2020-001170, and you will be advised when the Court takes action on your petition.

As to your general question about seeking relief under Rule 245 of the South Carolina Appellate Court Rules (SCACR), any petition that you desire to serve and file under that rule will need to comply with the requirements of Rules 245 and 240, SCACR.¹ Since you are incarcerated, however, you will only need to file one
